Discussion ensued regarding **cost containment efforts**. The City Administrator provided an overview and stated administration has done their due diligence. Cost containment efforts included reducing staff through attrition from 105 to 87 full time employees (18%) without having to reduce services, equipment replacement cycles have been postponed (computers, scout cars, and fleet inventory), and purchases have been delayed.

The Chair stated he has been impressed with the ability to maintain the fund balance.

The City Administrator stated that if it is necessary to cut services, those affected may include leaf pick up, plowing sidewalks, plowing and salting, and tree trimming.

## FINANCE COMMITTEE 01-30-12 - 04

The Mayor stated Grosse Pointe Woods wants to remain a point of destination, and that maintaining services is key. With cost containment efforts already implemented, additional substantial dollar cuts would be personnel, which would impact services. Reserves and expenses have been addressed, previous cost containment measures realized \$200,000, and substantial savings have been realized by reducing the number of employees without affecting services. He said that revenue now needs to be addressed and that the remaining .41 mills left on the Headlee cap will generate \$250,000. Further, normal road construction/maintenance ceased in 2008, when in prior years \$1-1.5 million was spent on road construction annually.

The Treasurer/Comptroller provided a brief millage history:

```
In 2007 1 mill = $867,000;
In 2012 1 mill = $595,000.
```

Council Member Koester stated his concern was regarding the level of public safety after staffing cuts. The City Administrator stated coverage is sufficient given the reduction in Command Officers, from 14 to 7, allowing for more patrols on the street.

Discussion then ensued regarding **proposed increase in current millage**. The current rate is rolled back to 14.0492, with approximately .41 mills remaining that the City Council can authorize be placed on the tax bills to generate approximately \$250,000. Including the projected 3% decline in taxable value, the budget would be approximately \$900,000 short of a balanced budget and funds would need to be taken from reserves. The current operating millage is 13.5660, but can go to 14.0492. The Mayor stated that if we wait until November \$250,000 in revenue would be lost in the first year, and if the proposal does not pass \$250,000 possibly lost the next year if the proposal does not pass. If .41 is approved by the City Council, it will be placed on the rolls in July and collected in 2012, at a cost of approximately \$20 to each resident annually. The Treasurer/Comptroller stated the City will need approximately 4 mills for road construction, capital equipment, and general operations.

# RESOLUTION TO MICHIGAN PUBLIC SERVICE COMMISSION REGARDING DTE ENERGY SMART METERS

WHEREAS, DTE Energy is in the midst of a comprehensive program for the installation of new meters to customers in the City of Grosse Pointe Woods, replacing existing meters with DTE Energy Smart Meters (computerized electric devices allowing for remote reading by DTE via radio frequencies), the Michigan Public Service Commission (MPSC) having jurisdiction in this matter; and
