12. New Business:

- Council adopted a Resolution in Support of Fully Replacing, Not Just Erasing, Michigan's Personal Property Tax.
- Council authorized the city administrator and city attorney to select a law firm to present an analysis of the efficacy of pursuing litigation regarding redistricting of the Grosse Pointes in an amount not to exceed \$4000.
- School of Choice legislation was discussed. Council Member Granger gave an overview of the grassroots effort to oppose this legislation. GPW was the first community to pass a resolution in opposition of the Schools of Choice Mandate, now other school districts and cities are following suit.
- Council directed the Treasurer/Comptroller to provide a report by mid October containing:
 - Adjustments to revenue, pluses and minuses for FY 11/12 that have taken place or will take place since the budget was adopted.
 - Expenditure changes since the budget was adopted, both real and projected.
 - Tax revenues for next year.
