- 3. The granting of the variance is within the intent and spirit of the ordinance. The intent of the ordinance is to provide for safety of access to all areas of the house, separation from adjoining uses and structures, and for open space between buildings;
- 4. The proposed home has an attached garage. The side yard can be reduced and still provide for the setback consistent with the surrounding area;
- 5. The hardship has not been created by the applicant;
- 6. Construction commence within six months, and complete within one year.

RESOLUTION

Be it resolved by the City Council of the City of Grosse Pointe Woods as follows:

WHEREAS, the requisite number of signatures of registered voters of the City of Grosse Pointe Woods having been provided to the City Clerk on August 7, 2006: two days before the eventual deadline established by statute, and

WHEREAS, the purported number of necessary signatures for amending the City Charter by initiatory petition having been received by the City Clerk, and

WHEREAS, the City Clerk having verified those signatures on August 11, 2006 and that verification being within the 45 day time limit as provided by law for her verification, and

WHEREAS, the next general election date being November 7, 2006, and

WHEREAS, the requisite number of electors of the City of Grosse Pointe Woods, by initiatory petition pursuant to the authority granted by MCL 117.21 propose that the following amendment language be added to the Charter of the City of Grosse Pointe Woods:

NO PERSON SHALL BE ELECTED TO THE OFFICE OF MAYOR MORE THAN TWO TIMES. NO PERSON SHALL BE ELECTED TO THE OFFICE OF COUNCILPERSON MORE THAN TWO TIMES.

WHEREAS, the current Charter of the City of Grosse Pointe Woods has no such restrictions on the term limits of the Mayor or Councilmen,

IT IS RESOLVED THAT:

- 1. The City Clerk shall forthwith transmit a copy of the proposed amendment and this Resolution to the Governor of the State of Michigan for her approval, and transmit a copy of such proposed amendment to the Attorney General of the State of Michigan for his approval as required by law.
- 2. Subject to the requisite approvals as mandated by law, the proposed Charter amendment shall be, and the same is to be submitted to the qualified electors of this City at the next general election to be held on Tuesday, November 7, 2006 and the City Clerk is hereby directed to give notice of the election and notice of registration therefore and the manner prescribed by law and to do all things and to provide all supplies necessary to submit such charter amendment to the vote of the electors as required by law. Pending the necessary approval from the Governor, the City Clerk shall transmit a copy of the proposed amendment, this resolution, and a copy of the actual petitions received to the Wayne County Bureau of Elections.
- 3. The proposed amendment shall be submitted to the electors in the following form, to wit:

 Should the Charter of the City of Grosse Pointe Woods be amended by adding the following term limit language:

NO PERSON SHALL BE ELECTED TO THE OFFICE OF MAYOR MORE
THAN TWO TIMES. NO PERSON SHALL BE ELECTED TO THE OFFICE OF
COUNCIL PERSON MORE THAN TWO TIMES.
