FOR A ZONING BOARD OF APPEALS HEARING UNDER THE PROVISIONS OF CHAPTER 98, ZONING, ARTICLE XIV, SECTION 98-401 OF THE 1997 CITY CODE TO HEAR THE APPEAL OF **POWER BARRE STUDIOS LLC, 20250 MACK AVENUE, GROSSE POINTE WOODS**, WHICH IS APPEALING THE DENIAL OF THE BUILDING INSPECTOR TO ISSUE A BUILDING PERMIT FOR 20250 MACK AVENUE, GROSSE POINTE WOODS.
