ESTABLISHING RULES FOR REMOTE ATTENDANCE BY MEMBERS OF GROSSE POINTE WOODS CITY COUNCIL AND OTHER CITY PUBLIC BODIES AND MEMBERS OF THE PUBLIC AT PUBLIC MEETINGS DUE TO CORONAVIRUS PANDEMIC

Minutes of a regular meeting of the City Council of the City of Grosse Pointe Woods, State of Michigan (the "City"), held electronically on May 4, 2020, at 7:00 p.m., prevailing Eastern Time.

WHEREAS, the Michigan Department of Health and Human Services (MDHHS) issued Interim Recommendations for COVID-19 Community Mitigation Strategies; and

WHEREAS, such strategies include encouraging staff to tele-work when feasible, implementing social distancing measures, including limiting in-person meetings, and limiting large work-related gatherings; and

WHEREAS, on March 18, 2020, Governor Whitmer issued Executive Order 2020-15 (as amended by EO 2020-48) which temporarily suspends certain rules and procedures relating to physical presence of members at meetings and hearings of public bodies so as to enable public bodies to continue to conduct public business during the COVID-19 emergency and so as to enable the general public to continue to participate in government decision making without unduly compromising public health, safety, and welfare; and

WHEREAS, to implement MDHHS's mitigation strategies and allow the City Council and all other City boards, commissions, and committees (hereinafter referred to collectively as "Public Bodies") to continue to conduct public business, and to allow City Officials, City Employees, and the public to attend meetings of the Public Bodies remotely, consistent with and in compliance with Executive Order 2020-15 (as amended by EO 2020-48), and consistent with the City Council's ability to amend its own Rules of Order of Common Council the Grosse Pointe Woods City Council desires to establish rules regarding remote attendance set forth in this Resolution;

NOW, THEREFORE, BE IT RESOLVED that the Grosse Pointe Woods City Council immediately authorizes its members, City Officials, City employees, members of other Public Bodies, and members of the public to attend all meetings of Public Bodies by telephone or other electronic means and establishes rules as follows:

A. NOTICE OF MEETINGS:

1. For every meeting to be held remotely pursuant to this Resolution, the City Clerk shall post the appropriate notice consistent with the Open Meetings Act, EO-2020-48, and City Code.

B. CONDUCT OF THE MEETING:

- 1. The telephone or other electronic technology utilized for the remote meeting shall permit the members of the Public Body in attendance to hear and be heard by the other members of the Public Body in attendance, and shall permit the participants from the general public to hear the members of the Public Body and be heard by the members of the Public Body and the other participants during a public comment period.
- 2. A member's remote attendance shall be considered attendance for the purpose of establishing a quorum.
- 3. Any vote by a member participating remotely pursuant to this resolution shall be counted in the total number of votes for any matter and shall not be held invalid for the reason that it was cast by a member remotely.
- 4. Roll call votes shall be taken if it is clear that the vote was not unanimous, or in any event at the request of the Chair or City Clerk.
- 5. For closed sessions conducted under this policy, each member and authorized attendee of the closed session shall not allow anyone else to hear or view the closed session.
- 6. Emails, texting, or other forms of electronic communication by or between

members during the meeting shall not be allowed.

7. Agenda items regarding Pledge of Allegiance to the Flag and Recognition of Commission Members are temporarily suspended.

C. ATTENDANCE BY MEMBERS OF THE PUBLIC:

1. If any member of the public is attending remotely, each member of the public shall be provided an opportunity to provide public comment during a public comment portion of the agenda. The Chair will first request comment from the public, and then may request comment from Council Members.

D. EFFECTIVE DATE AND TERM:

 This Resolution and procedures shall remain in effect until modified by the City Council. If the EO 2020-59 or other "social distancing" orders or guidelines are modified or terminated, this Resolution allowing remote participation by members of "public bodies" and members of the public, shall continue to apply until modified by City Council. The City Council may revisit the applicability of this Resolution at any time in its discretion.

This Resolution is intended to establish rules for and authorize participation by remote access by members of City of Grosse Pointe Woods Public Bodies and attendance by remote access by members of the public in the interest of the public health, safety, and welfare during the COVID-19 outbreak and after while preserving meaningful access to meetings and communication for Public Body members and members of the public.

MINUTES OF THE REGULAR CITY COUNCIL MEETING OF THE CITY OF GROSSE POINTE WOODS HELD ON MONDAY, MARCH 16, 2020, IN THE COUNCIL-COURT ROOM OF THE MUNICIPAL BUILDING, 20025 MACK PLAZA, GROSSE POINTE WOODS, MICHIGAN.

The meeting was called to order at 7:03 p.m. by Mayor Novitke.

Council, Administration, and the audience Pledged Allegiance to the Flag.

Hearing no objections, New Business was moved to the beginning of the agenda. The Mayor spoke regarding the CORONA-19 virus and that the City Council should consider the following:

- 1. Consideration be given to postpone all Council and Commission meetings until May, unless new news is received, and then call a Special Council Meeting if there is something needed to address.
- 2. E-blasts to keep community up to date with changes relating to Coronavirus regarding cancellations and new information, and encouraging individuals to sign up with contacts through website/newspapers.
- 3. Develop COVID-19 strategies.
- 4. Acknowledge there will be some emergency expenditures by the City Administrator that he would have to report to the City Council.
- 5. Not a time for panic, but it is a time for caution.

Council also discussed the following:

- 1. Cancel Flower Sale.
- 2. Cancel Lochmoor event for Beautification Commission awards, which night the City could plan and make up the difference with City funds in the future if possible. In order to prepare, people need to be contacted, need to deal with vendors, and will need to determine what the status of Lochmoor will be at that time.
- 3. Cancel entertainment contracts for City sponsored events now, and wait and see to consider other things down the line; contracts for various City events such as Music on the Lawn and Fall Fest. If something changes the City can put something together pretty quick. Need to consider preparation for food, entertainment, and sponsor letters.
- 4. Consider canceling all City sponsored events including ice cream social, Memorial Day, and Tree Dedication Ceremony.

Other New Business discussed included discussion ensued regarding use of the pool and the marina, as well as water cresting the docks. The City Administrator provided an overview regarding neighboring City Hall closures to the public. Concerns were raised regarding use of the showers, walking through the showers, use of lavatories, walking the pool deck, and the number of people with respect to gatherings; but need to wait and see what is ordered by the Governor. The Mayor stated we will be postponing meetings until May with his ability to call a Special Meeting if something comes up to be addressed. When we return in May, approve the cost for opening/closing the pool, and we will be prepared. He stated once the virus crests it will take time to level off.

The Treasurer/Comptroller confirmed May 4th as the date on which the Council will set the Budget Public Hearing for May 18th. Discussion ensued regarding adopting the budget, Finance Committee Meetings to prepare for the budget, and observing the Open Meetings Act. The City

Attorney stated with respect to telecommunications, the City can open a room, have members call in as long as the public can hear what is discussed and participate in the meeting. State agencies have been permitted to teleconference. There was a discussion regarding attending meetings remotely by use of speaker phone and observing social distancing. The Treasurer/Comptroller was asked to provide the budget books earlier than usual, study them, pose questions to the City Administrator or Treasurer/Comptroller, and have one meeting. There was a brief discussion regarding the need to set a Compensation & Evaluation

Committee Meeting. There were suggestions to use Alexa View or Zoom for teleconferencing in the event a member is sick providing the ability to call in for purposes of attending meeting. A brief discussion ensued regarding Municipal Court needs.



Dear Mayor and Council:

On March 5, 2020, the City notified AT&T, Comcast, and WOW that it had cancelled the PEG services with the Grosse Pointe War Memorial. The letter notified each carrier that the City intended to eliminate PEG services to residents and that the carriers should no longer bill residents for PEG services. I am following up with all three carriers to implement this action.

I have now enclosed the cover letter from AT&T and "attachment 2" to the Uniform Video Service Local Franchise Agreement for approval and processing. This attachment is a simple amendment which makes clear that the PEG fee is reduced from 2% to 0%. It is anticipated that the City will receive similar requests from Comcast and WOW in the near future.

It would be the prerogative of Council to authorize the amendment to the Video Service Local Franchise Agreement with AT&T to reduce the current PEG fee to 0%, authorize the City Administrator to sign the attachment, and further authorize the City Administrator to sign similar amendments with Comcast and WOW reducing the PEG fee to 0% after review of the proposed amendment by the City Attorney.

MDEQ - EGLE Subsurface Investigation of the Underground Fuel Tanks - DPW

On July 18, 2018, the city was informed that the old gasoline and diesel underground storage tank had a fuel release at the Department of Public Works yard. The Michigan Department of Environmental Quality (MDEQ) was notified as required.

The State of Michigan provides coverage for pollution control removal for municipalities. The coverage is provided by the Michigan Underground Storage Tank Authority (MUSTA) with a \$2,000.00 deductible fee, previously approved by Council on 4/9/2018.

The initial subsurface investigation was done to determine if the soil and groundwater were impacted. Also, required was the completion of an Initial Assessment Report for submittal to the Michigan Department of Environmental Quality (MDEQ). Groundwater & Environmental Services, Inc. was hired by the city to perform this work. To date, the city has been reimbursed a total, of \$20,516.70 under the Michigan Underground Storage Tank Authority (MUSTA) fund.

For clarification, the Michigan Department of Environmental Quality (MDEQ) is now known as the Department of Environment, Great Lakes, and Energy (EGLE).

On September 13, 2019, Groundwater & Environmental Services, Inc. on behalf of the City of Grosse Pointe Woods submitted the findings of the Initial Assessment Report of the gasoline and diesel release area to the Department of Environment, Great Lakes, and Energy (EGLE). On December 13, 2019, the Department of Environment, Great Lakes, and Energy (EGLE) concluded that additional testing outside of the initial investigation area is required before the report may be finalized.

The Department of Environment, Great Lakes, and Energy (EGLE) is requiring additional subsurface investigation to determine if a larger area of soil and groundwater was impacted. This work includes the placement of additional soil borings and monitoring wells to evaluate the groundwater conditions outside of the prior location of the fuel tanks. Also included is the completion of the Final Assessment Report for submittal to the Department of Environment, Great Lakes, and Energy (EGLE).

Therefore, I recommend Groundwater & Environmental Services, Inc. to complete this mandatory work. The city will have to pay Groundwater Environmental Services, Inc. and the cost will be reimbursed under the Michigan Underground Storage Tank Authority (MUSTA). Groundwater Environmental Services, Inc. handles all of the preparation and submittal to the Michigan Underground Storage Tank Authority (MUSTA). Listed below is the breakdown of the proposed costs:

Scope of Work

The purpose of this cost estimate is for the required assessment, monitoring and reporting activities pursuant to the Michigan Department of Environment, Great Lakes, and Energy (EGLE), Remediation and Redevelopment Division (RRD) Part 213, Section 324.21311a of the Leaking Underground Storage Tanks, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

This cost estimate comprises the activities required by EGLE to complete its evaluation of the Final Assessment Report (FAR) and to petition the EGLE for Closure of the open confirmed gasoline and diesel release C-0135-18 at the City of Grosse Pointe Woods — Department of Public Works (DPW) yard.

On September 13, 2019, as required by Part 213, Leaking Underground Storage Tanks, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended. Groundwater & Environmental Services, Inc. (GES) on behalf of the City of Grosse Pointe Woods - DPW, submitted a FAR to the EGLE -RRD, for the open gasoline and diesel release C-0135-18 from the former underground storage tank (UST) system at the City of Grosse Pointe Woods - DPW yard, located at 1200 Parkway Drive, Grosse Pointe Woods, (site).

On December 13, 2019, in a letter titled "Final Assessment Report: Insufficient Information", the EGLE concluded that they do not have sufficient information to make a decision that corrective actions have been conducted to approve the FAR.

On January 24, 2020, GES met with the EGLE on behalf of City of Grosse Pointe Woods - DPW to clarify EGLE's concerns for the site. The EGLE requested further soil, groundwater and soil vapor data in order to complete its review of the FAR. Consequently, additional monitoring wells and/or soil borings are required in order to define the shallow contamination on site. Likewise, additional sub-slab vapor pins are necessary to assess the indoor air intrusion pathway within the maintenance buildings. While traditionally, the EGLE relied on selected indicator compounds to define soil and groundwater contamination, currently, the EGLE requires that all regulated substances that the UST system contained at the time of the release, or contained historically shall be evaluated. Consequently, soil and groundwater analysis must comprise a full scan of Volatile Organic Compounds (VOCs) and Semi-Volatile Organic Compounds (SVOCs).

The following activities are required by EGLE to complete its evaluation of the FAR and to achieve Closure of the open gasoline and diesel release C-0135-18.

Phase I

- 1. Task 02/100. Work Plan Preparation. GES will prepare detailed work plans to complete the required subsurface investigations including installation of Monitoring Wells, Soil Borings, Sub-Slab Vapor Pins, and subsequent groundwater and soil vapor sampling activities.
- 2. Task 02/101. HASP Preparation/Update. GES will prepare and implement a written health and safety plan (HASP) in accordance with OSHA's HAZWOPER standard (29 CFR 1910.120).
- 3. Task 02/201. Well Installation/Soil Borings. GES will oversee installation of up to 20 additional shallow monitoring wells and/or soil borings in order to define limits of the contamination on-site, three (3) of the soil borings may be installed

inside the maintenance building. The obtained soil samples will be analyzed for Total Petroleum Hydrocarbons (TPH) Gasoline-Range Organics (GRO) and Diesel range organics (DRO) as well as full scan of VOCs and SVOCs. This work will be scheduled for Q2 2020.

- 4. Task 02/201. Sub-Slab Vapor Pins Installation. GES will install up to 12 additional sub-slab vapor pins through the floor of the maintenance buildings, based on sampling density in a commercial building greater than 10,000 square feet. This is to assess the indoor air intrusion pathway associated with potential diesel/gasoline vapors migrating through subsurface soils into the overlying buildings. This work will be scheduled for Q2 2020.
- 5. Task 02/206. Monitoring Well Sampling. GES will complete four (4) quarters of groundwater sampling from all existing monitoring well locations for laboratory analysis of full VOCs and SVOCs scan in accordance with the EGLE current recommendations. This work will be scheduled for Q2 2020 through Q1/Q2 2021.
- 6. Task 02/210. Air Monitoring/Sampling Sub-Slab Vapor Pin Sampling. GES will complete four (4) quarters of soil vapor sampling from all existing sub-slab vapor pin locations for laboratory analysis in accordance with the EGLE current Guidance Document for the Vapor Intrusion Pathway, Appendix F.3 Sampling Utilizing USEPA Method TO-15. This work will be scheduled for Q2 2020 through Q1/Q2 2021.
- 7. Task 02/191 and Task 02/193. Client/Third Party Meetings, Correspondence and Communications with EGLE and the Client throughout duration of the project to discuss remedial requirements and path to closure.
- 8. Task 02/194. Reimbursement Agency invoice submittal and correspondence throughout duration of the project.

Phase II

- 9. Task 02/815. Conceptual Site Model (CSM) Development. Upon obtaining the additional data, GES will update the CSM describing human health and ecological risk assessment. The CSM will evaluate exposure pathways to human and ecological receptors i.e. physical, chemical and biological processes that control the transport, migration and current or potential impacts of contamination in soil, groundwater, and soil vapor to human and/or ecological receptors. To be completed by Q3 2021.
- 10. Task 02/118. Deed/Registry Research Restricted Covenant (RC). GES will finalize Nonresidential Land and Resource Use Restrictions for the site. The proposed RC will ensure that the use of the property remains commercial, and warrant that a protective barrier i.e. asphalt/concrete remains in place to prevent direct contact with the contaminated soils. Further the RC will prohibit construction of wells to extract groundwater in the area subject to the restrictions and require an evaluation and/or mitigation of potential vapor risks. The final executed copy of the RC will be recorded at the Wayne County Register of Deeds Office. To be completed by Q3 2021.
- 11. Task 02/284. Site Survey. A professional survey of the entire property and survey of the area subject to the above restrictions will be completed and included in the final executed copy of the RC. To be completed by Q3 2021.

Phase III

- 12. Task 03/138. Site Closure Report. Upon four (4) quarters of satisfactory laboratory data GES will draft and submit a Closure Report to EGLE-RRD. As required by Part 213, Leaking Underground Storage Tanks, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended. The Closure Report will include Summary of Corrective Action Activities and documentation of that the corrective actions that have been completed, closure verification sampling results, and the recorded RC. Prior to submittal to the EGLE-RRD an electronic copy of the Closure Report will be submitted for your review and signature. To be completed by Q4 2021.
- 13. Task 03/297. Well Abandonment. Upon EGLE approval of the Closure Report within 180 days and closure of the C-0135-18 release, GES will abandon all monitoring wells and sub-slab vapor pins on site. To be completed by Q3 2022.

Michigan Underground Storage Tank Authority (MUSTA) Cleanup Fund Claim Number 18-091 for the above-mentioned facility, has been approved for a maximum reimbursement limit of \$1,000,000.00 minus deductible of \$2,000. The Claim Balance is \$965,029.05.

Specifically, this proposal includes project tasks requested by EGLE during the January 24, 2020, FAR: Insufficient Information meeting. The estimated costs include the work required to attain the additional soil, groundwater and soil vapor analytical data to be obtained during subsurface investigations and subsequent four (4) quarters of groundwater and soil vapor sampling. This proposal does not include any additional work, which may be further required by the EGLE as a result of the analytical data obtained. If additional work is required by the EGLE, another proposal will be provided to City of Grosse Pointe Woods — DPW for further assessment and reporting activities.



STANDARD TERMS & CONDITIONS (01-2018)

These Terms and Conditions (the "Agreement") are entered into this ______day of April 2020 (the "Execution Date") by and between the City of Grosse Pointe Woods – Department of Public Works (DPW). ("Client") and Groundwater and Environmental Services, Inc. ("GES").

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, Client and GES agree as follows:

- The services described in Proposal for Work Required by EGLE 1. Scope of Services. to achieve Closure, GES Proposal # MI-2019-0044-02 and/or dated March 6, 2020 ("Proposal") shall be authorized by Client by providing an authorized signature on the Proposal (with the Proposal as authorized by Client hereinafter referred to as the "Services") and shall be performed in accordance with the terms and conditions of this Agreement. Any changes or additions to the Services shall be set forth exclusively as a change order to the Proposal (in a form either agreeable to the parties or implied by conduct) before the Services are performed. Any changes or additions to this Agreement shall be set forth exclusively as a written amendment executed by the parties, with any additional, different and/or conflicting terms and conditions contained in Client's purchasing documents or other correspondence, any other change or addition to the Services or this Agreement by any other method, being null and void and of no force and effect. As a condition precedent to GES' obligation to perform Services under this Agreement, Client shall, if requested by GES, complete GES' standard credit application and provide any requested financial information in order to assess the creditworthiness of Client. GES may, in its sole discretion, impose credit limits on Client.
- 2. Standard of Care. GES will perform the Services with the degree of skill and care ordinarily exercised by qualified professionals performing the same type of services under similar conditions in the same or similar locality. The foregoing standard is in lieu of all other standards and warranties, expressed or implied, including warranties of marketability or fitness for a particular purpose. Client acknowledges that environmental conditions at any site can and will vary from those encountered at the times and locations of the performance of the Services thereby resulting in various degrees of uncertainty with respect to the interpretation of environmental conditions despite due professional care.
- 3. <u>Compensation.</u> Unless otherwise stated in the Proposal, GES shall be compensated for the Services on a time and materials basis in accordance with GES' Personnel Rate Schedule and the Rental and Equipment Rate Schedule attached as Exhibit A to this

Agreement (the "Rates"), including, and without limitation, any applicable taxes or other reasonable expenses. GES shall submit invoices monthly and Client agrees to pay such invoices within thirty (30) days of the invoice date. GES reserves the right to charge interest at the rate of .75% per month on overdue payments and Client agrees to pay any reasonable attorney's fees or other costs incurred by GES to collect amounts deemed delinquent by GES. GES reserves the right to modify the Rates at any time upon thirty (30) days written notice to Client.

- 4. <u>Term.</u> Unless otherwise stated in the Proposal, or terminated in accordance with Paragraph 16 of this Agreement, this Agreement shall expire upon the completion of the Services.
- 5. Access. Where the Services necessarily require entering into, upon or under real property, including improvements located thereon (the "Site"), Client hereby grants such access, or shall cause such access to be granted, and represents and warrants that GES has such access to the Site in order to perform the Services without delay or hindrance.
- 6. Information Provided By Client. Client shall provide to GES all information pertaining to the Services and/or the Site that is known to exist by Client including, without limitation, information related to (a) solid waste, hazardous wastes, substances or materials, toxic wastes, substances or materials, pollutants, contaminants, petroleum or its additives (as any of the above terms may be defined under federal, state or local law ("Law")) (collectively, "Hazardous Substances"); (b) aboveground or underground facilities or services including, without limitation, utilities, conduits, lines, pipes, tanks, containers and/or wires (collectively, "Utilities"); and (c) subsurface conditions or obstructions. Client represents and warrants that GES shall be permitted to rely on such information.
- 7. <u>Utilities/Underground Facilities</u>. GES shall review the information provided under Section 6 of this Agreement and shall contact the customary governmental and/or private entities regarding the existence and location of Utilities prior to conducting any subsurface penetrations. GES shall not be responsible for, and Client shall indemnify, defend and hold GES harmless from and against, any claims for any losses or damages arising from or related to damage to Utilities not identified or not accurately located in accordance with this Section 7.
- 8. Confidentiality. GES and Client shall treat as confidential and proprietary all information and data delivered to it by the other party which, without limitation, relates to technologies, formula, procedures, costs, processes, operations, methods, trade secrets, ideas, computer programs, customers, products, equipment or are designated in writing as confidential at time of delivery (collectively, "Confidential Information") and shall not disclose Confidential Information to any third party during or subsequent to the term of this Agreement; provided that such disclosure shall not apply to information and data which are actually known by the disclosing party before obtained from the transmitting party, information and data which are generally available to the public through no fault of disclosing party, or where disclosure is required by law; provided that the disclosing

- party gives reasonable notice of its intent to disclose in accordance with law allowing the other party to make any reasonable objection to such disclosure.
- 9. <u>Intellectual Property.</u> GES shall retain all right, title and interest in and to all intellectual property including, without limitation, patents, copyrights, trademarks, trade secrets, patentable and unpatentable inventions (collectively, "Intellectual Property Rights") used or developed by GES in connection with performing the Services including all Intellectual Property Rights relating to all articles, techniques, processes and operations.

10. Limitations on Services.

- a. <u>Liability Limitations</u>. In addition to the limitations set forth in Section 7 hereof, GES' liability under the provisions of this Agreement or in connection with its performance of the Services, whether based on contract, tort, breach of warranty, professional negligence (including errors, omissions, or other professional acts) or otherwise, shall be limited in each case to the amount recovered by GES under the insurance policies identified in Paragraph 11 of this Agreement or the contract amount set forth in the applicable Proposal, whichever is less. Client hereby forever releases GES from any liability, losses or damages sustained and incurred by Client in excess of such amounts. In no event shall GES be liable for any incidental, indirect, special, punitive, economic or consequential damages (including but not limited to loss of profits) suffered or incurred by Client as a result of this Agreement or GES' performance or non-performance of the Services.
- b. Reliance by Third Parties. The Services are performed, and information, data, interpretations or reports, and the like, that may be prepared as part of the Services ("Instruments of Service") are prepared, for the sole purpose of the Client who may use and rely on the Services and the Instruments of Service for their intended purpose, subject to the other terms and conditions of this Agreement. There are no third party beneficiaries to this Agreement. Client may request that third parties be extended the right to rely on the Services and the Instruments of Service, and such reliance may be granted, in the sole discretion of GES, but only when such parties agree to be unconditionally bound to GES' standard terms and conditions in effect at the time of the request and GES is reasonably compensated for extending such reliance to such third parties.
- c. <u>Liability for Hazardous Substances</u>. Client acknowledges and agrees, and will not dispute, that GES is not, and has no authority to act as on behalf of Client, a generator, an arranger for disposal or treatment, or an arranger with a transporter for transport for disposal or treatment, of any Hazardous Substances that may be present, found or identified at, on, in, above, to, from or under any Site or other sites that may the subject of or related to the Services. Any assistance provided by GES to Client for the treatment, storage, transport or disposal of any Hazardous Substances including, without limitation, Client's written request that GES sign Client's manifests as its authorized agent, are made solely and exclusively for the benefit and convenience of Client and shall impose no

liability upon GES. Client shall manage all Hazardous Substances in compliance with Law. Unless otherwise agreed, Client shall sign all manifests and obtain all generator identification numbers when required by Law or when requested by GES. GES may furnish the Client the names of facilities currently licensed to accept Hazardous Substances, but it shall be the Client's sole responsibility to select those to be engaged by Client.

11. <u>Insurance.</u> GES shall maintain the following minimum insurance coverage while performing the Services:

Workers Compensation and Employer's Liability: \$1,000,000

Commercial General Liability: \$1,000,000 Each Occurrence,

\$2,000,000 Aggregate

Automobile: \$1,000,000

Excess Liability: \$10,000,000

Pollution & Professional Liability: \$1,000,000 Each Occurrence and \$2,000,000 in the

Aggregate

- 12. <u>Indemnification.</u> Subject to the provisions of Paragraph 10 of this Agreement, GES shall indemnify Client from and against any liabilities, losses, claims, orders, damages, fines and penalties (collectively, "Claims") arising out of or related to negligent acts or omissions of GES in the performance of the Services. Client shall indemnify, defend and hold GES harmless from and against any Claims arising out of or related to (i) the negligent acts or omissions, or violations of Law, of Client and (ii) Hazardous Substances that are present at, released to or from, treated at, or removed from, the Site.
- 13. <u>Independent Contractor.</u> GES is an independent contractor and assumes no obligation or responsibility as an agent, partner, or joint venturer of Client.
- 14. <u>Force Majeure.</u> GES shall have no liability for failure to perform or delay in performance caused by conditions or events beyond GES' control including, without limitation, strike, fire, flood, explosion, acts of nature, acts of government, act of war, riot, terrorism, labor disputes or disturbances, transportation delays, the inability to obtain material or equipment, or the discovery of Hazardous Substances that were previously unknown.
- 15. <u>Dispute Resolution.</u> Any dispute arising out of or related to the Services or this Agreement shall be resolved, if not first by reasonable negotiation, by binding Arbitration under the applicable rules of the American Arbitration Association.

- 16. <u>Termination</u>. Either party may terminate this Agreement upon thirty (30) day written notice to the other party. Should Client terminate this Agreement, Client shall reimburse GES for its actual fees, expenses and costs that have been generated, incurred, expended or committed in furtherance of the Services and the reasonable costs associated with termination, including demobilization.
- 17. <u>Integration</u>. This Agreement is the exclusive record of the parties' agreement. The parties intend the terms and conditions of this Agreement to constitute the final, complete, exclusive and completely integrated terms and conditions to which they intend to be bound and they do not intend to be bound by any other agreements, promises, conditions or representations, or any additional or different terms and conditions that may be contained in documents transmitted to GES, written or oral, of whatsoever kind or nature.
- 18. <u>Severability</u>. In the event that any provision of this Agreement is held to be unenforceable under law, the remaining provisions shall remain in full force and effect.
- 19. Governing Law. This Agreement shall be governed by the law of the Commonwealth of Pennsylvania.
- 20. <u>Survival.</u> The provisions in Paragraphs 7, 8, 10, 12 and 15 of this Agreement shall survive the expiration or earlier termination of this Agreement.






