• The Treasurer/Comptroller discussed the State's recent denial of the City's 2017/18 Corrective Action Plan for the City's Retiree Health Care Plan. She informed the City Council that the State is requiring a plan from the City to be 40% funded within 30 years. She said the Actuary can perform a study that will identify an annual contribution to the Retiree Health Care Plan for a recommendation to be provided to the Retiree Health Care Board, and that a response is due to the state

within sixty days. The Actuary, Sandy Rodwan, has agreed to perform the 30-year study to calculate a proposed contribution at a cost of \$1,800.00 prior to the February Pension Board Meeting, funds to be taken from the Finance Department's budget.

Motion by Granger, seconded by Shetler, regarding the Retiree Health Care Plan, that the City Council approve the employment of Sandy Rodwan at a cost not to exceed \$1,800.00 for purposes of preparing an actuarial study in accordance with the Retiree Health Care Act known as P.A. 202.

Under discussion, the Treasurer/Comptroller stated the City's Pension Attorney, Mr. VanOverbeke, recommends employing the services of Ms. Rodwan to prepare the study. The City Attorney also concurred.
