SUBJECT: Request for fence variance

Our family of four moved to Grosse Pointe Woods on September 11, 2016. This past summer, I reached out to my adjacent neighbors to notify them of my proposal to replace our fence. Kathleen & Salvatore Ciaramitaro, who live behind me, agreed that the fence needed to be replaced and offered financial support; as did our neighbors, Soula & Pat Burns. My third adjacent neighbors, Barb and John Earl, were unreachable all summer which prevented me from discussing the fence proposal with them. My understanding is that they go to their summer cabin in northern Michigan for the summer. I attempted to reach out to them via phone and left voicemails with no return call. I also reached out to their daughter, via text, in attempt to discuss the fence with Mrs. and/or Mr. Earl.

During the months of July and August, I followed the proper guidelines and requirements requesting an exception to Ordinance #871 to allow me to install a 6-foot fence. I presented my fence variance during the city council meeting on Monday, August 20, 2018, and the council approved a 6' cedar shadowbox fence to be placed at the entire rear perimeter (including two gates at each side 10' back from the front). At that time, I did not know the existing fence on the east side of the property is owned by my neighbors, as I could not reach them.


After finally speaking with Mr. Earl, he made it clear that he does not want the fence removed; which is a 20-year-old, 4-foot, dilapidated fence that is the only barrier between my small children and his pool. Therefore, I am requesting to appeal the ordinance as indicated in Section 8-279 (5) 'No fence shall be erected adjacent to another fence'. I am seeking approval from the council to erect a brand new 6-foot cedar shadowbox fence on my property, adjacent to my neighbors existing fence. The safety and well-being of my children is still my number one concern regarding this matter.

I appreciate your time spent reviewing and considering my request.



The applicant is requesting a variance of Section 8-279(5) of the city's fence ordinance which prohibits a fence to be erected adjacent to an existing fence. The site plan and application submitted shows a 40' x 6' tall shadow box fence being installed adjacent to an existing 4' tall wood shadow box fence along the east property line. A variance has been previously granted to allow a 6' tall fence in this location.

The applicant has provided correspondence outlining the reasons for the variance dated October 3, 2018. The applicant has previously stated during the initial variance hearing on August 20, 2018 that neighbors on both sides of them have built-in pools and they are concerned that a 4' tall fence will not provide enough of a deterrent to keep their children out of the yards. They also indicate the neighbors with the pools support the variance due to the safety concerns. However, this statement is not entirely accurate after speaking with the owner to the east at 884 Woods Lane. He indicated to me that he was not notified of the proposed fence installation by the petitioner and did not receive notice of the appeal from the City, and if he had been made aware he would have objected to the fence and variance. He does not want his existing fence removed and replaced with one 6' tall.

I had a subsequent meeting with Mr. Earl, the owner of 884 Woods Lane. He indicated to me that he did not want his existing 4' tall fence removed and was not supportive of a 6' tall fence. However, in the interest of being a good neighbor he could live with a 5' tall fence. I reached out to the petitioner with this compromise and she rejected the proposal.

This exception to the fence code requires a public hearing and approval from the City Council. The City Council may consider any or all of the following, along with other information when deciding a variance:

- (a) Balancing the relative hardships between the property owner and adjacent property owners.
- (b) Whether special circumstances or conditions exist.
- (c) Whether pedestrian or vehicle traffic will be affected.
- (d) The general health, safety and welfare of the neighborhood.

A reasonable solution negating the need for a variance was proposed by the adjoining property owner that would have negated the need for a variance. A fence on a fence condition is unsightly for the neighbor and will result in an area that is extremely difficult to control weeds and the fence's maintenance.

After review of the application and inspection of the property, it is recommended that a variance of Section 8-279(5) not be granted allowing for the installation of the proposed 6' tall shadowbox fence resulting in a fence on fence situation as indicated on the attached sketch.

SUBJECT: Request for fence variance

Our family of four moved to Grosse Pointe Woods two years ago, and we love and support the GPW community. We are grateful that we live in a city that prioritizes the safety and well-being of its citizens.

With that being said, I want to do all that I can to ensure that my 3-year old son and 6-year old daughter have a safe outdoor yard to play in. Given that our neighbors on both sides of us have in-ground swimming pools, a crucial measure in safeguarding my children from a potential drowning scare or accident is by way of installing a fence that they will be unable to climb.

At my son's last doctor's appointment, he was measured at 3'1". A 4-foot fence simply would not provide enough height to deter a successful climb into either neighbor's yard and would not entirely eliminate the risk of drowning, which, according the the Center for Disease Control is the second leading cause of death for children between the ages of 1 and 4. Also, according to the Michigan Department of Health and . Human Services, "drowning is the number two cause of accidental death for children ages 14 and under," and finally, according to the Consumer Product Safety Commission (CPSC), " for children ages five and under, close to 350 drown in residential swimming pools each year."

As indicated in Section 8-284, the GPW City Council may grant exceptions to the 4-foot Fence Ordinance #871 under "special circumstances" pertaining to the "the general health, safety, and welfare of the neighborhood." I urge you to acknowledge that my children's perpetual risk of drowning constitutes a "special circumstance" pertaining to the "safety" of the neighborhood. Therefore, I ask that you make an exception to Oridance #871 and allow me to install a 6-foot fence in my rear and side yards.

I have two adjacent neighbors, Soula & Pat Burns and Kathleen & Salvatore Ciaramitaro, whom support the installation of a 6-foot fence due to the safety concerns I have outlined in this letter.

I appreciate your time spent reviewing and considering my request.



SUBJECT: 902 Woods Lane, Fence Variance

The applicant is requesting a variance of Sections 8-281 and 8-282(1) of the City's fence ordinance which limits the height of rear yard and side yard fences on interior lots to a maximum height of 4 feet above grade. The proposed 168 feet of shadowbox fence as shown on the application and site plan is 6' high across the rear and side yards of the property.

The applicant's property is a well-maintained home on an interior lot on the north side of Woods Lane.

This exception to the fence code requires a public hearing and approval from the City Council. The City Council may consider any or all of the following, along with the other information when deciding a variance:

- (a) Balancing the relative hardships between the property owner and adjacent property owners;
- (b) Whether special circumstances or conditions exist;
- (c) Whether pedestrian or vehicle traffic will be affected; and
- (d) The general health, safety and welfare of the neighborhood.

The applicant has provided correspondence outlining the reasons for the variance dated July 12, 2018. The applicant states that neighbors on both sides of them have built-in pools and they are concerned that a 4 foot tall fence will not provide enough of a deterrent to keep their children out of the yards. They also indicate the neighbors with the pools support the variance due to the safety concerns.


After review of the application and inspection of the property, it is recommended that a variance of Section 8-281 and 8-282(1) be granted allowing for the installation of the proposed 6 foot tall shadowbox fence as indicated on the attached sketch. The neighbor's in-ground swimming pools are a safety concern of the applicant. There does appear to be special circumstances relative to the general health, safety and welfare that exist which would justify the grant of this variance.




