Motion by Bryant, seconded by Ketels, that all items on tonight's agenda be received, placed on file, and taken in order of appearance.

The Committee commenced interviewing three candidates to fill vacancies on the Planning Commission:

At the conclusion of the interviews, there was a consensus of the Committee to defer a recommendation to allow a full Committee to be present at the May 21, 2012, Committee-of-the-Whole meeting.

Next, the Committee discussed **road improvement and ballot language**. The Treasurer/Comptroller distributed Combined Schedule of Principal and Interest Requirements for Road Improvement Bonds at \$10 million for 10 years and \$10 million for 15 years, which included anticipated loss of personal property tax (\$240,000.)

Motion by Bryant, seconded by Koester, regarding road improvement and ballot language, that the Committee-of-the-Whole recommend that City Council approve road improvement program bonding language to include \$10 million for 10 years.

The following items were discussed under New Business/Public Comment:

• The City Administrator and Director of Public Safety discussed the Citizens' Public Safety Academy, and distributed an informational sheet. The program would begin in September. On an annual basis, the two-hour sessions would include sixty applicants per class.

There was a consensus to approve and authorize administration to move forward with establishing the Citizens' Public Safety Academy Program at a cost not to exceed \$500.00.

- The Mayor discussed the Grosse Pointe Community Chorus' 60th Anniversary. There was Committee consensus to voice no objections to the issuance of a Mayoral proclamation in recognition of the Grosse Pointe Community Chorus' 60th Anniversary.
- Lisa Howle, 1239 Sunningdale, was heard regarding proposal language and placing the proposed budget on the website.
- Pete Waldmeir, 514 Hollywood, was heard regarding language in both proposals.
- Joe Sucher, 730 S. Oxford, was heard regarding the formation of a Blue Ribbon Sub Committee.

- Jim Schultz, 20045 Holiday, was heard regarding the Citizen Police Academy and Ballot proposals.
- Christine Kaczanowski, 19888 William Ct., was heard regarding the Citizen Police Academy.
- Judy Sheehy, 941 Woods Lane, was heard regarding the proposed budget and millage proposal.
