Camera System and Body Cameras Purchase

The department is requesting to replace the current in-car video equipment camera system with up-to-date technology and to purchase body cameras.

Although these items were removed from the 2020/2021 Fiscal Year budget worksheet in the Minor Equipment account 101-310-970.000, we are requesting to have them put back in due to the current situation involving policing in our country. Now would be the best time to replace the department's entire system as the current video equipment has reached the end of its lifespan.

In the department's search for getting the best quality product for the best price for this major purchase, quotes were requested from Axon.com, Midwest Public Safety, and WatchGuard. Quotes were received from Axon.com and Midwest Public Safety at costs of \$205,132.00 and \$181,195.16, respectively. WatchGuard failed to bid.

A number of other departments currently utilizing the Getac system include Bloomfield Hills, Marine City, the Michigan State University Public Safety Department, Midland, Port Huron, and Toledo, The department received a positive review of Getac Video Solutions from Grosse Pointe City, which has been using the system for the past year and a half.

As a result, the department has decided that the best option would be to purchase the Getac Video Solutions camera system from Midwest Public Safety, LLC in Decatur, Illinois. The department is requesting to purchase eight in-car video systems and thirty-three body worn devices with Cloud management. The department is purchasing body camera for all road patrol officers as well as the Animal Control officer, Parking Enforcement officers and the Code Enforcement officers. The purchase would include vehicle installation of the Getac system and on-site training. A full five-year replacement warranty, licensing, and support would also be included.

Two purchase options are available. The first option would be to purchase the system at a total system cost of \$181,195.16 which would cover the first five years after which the service cost would be \$20,380.00 annually for 24/7 support, maintenance, and Cloud storage. The second option would be to finance the system at a cost of \$39,851.37 per year for five years for a total cost of \$199,256.85 with a 60 month \$1 buyout lease. A sample contract for financing has been reviewed and approved by City Attorney Charles Berschback should the City decide to choose this option. However, the City would save \$18,061.69 in addition to the cost of any doc fees by paying for the entire cost of the system at the time of purchase.

The utilization of body cameras would bring the department into the 21st century with the widely-used tool used to reduce citizen's complaints and agency liability. The use of body cameras also captures valuable evidence. Unlike dashboard cameras, these cameras record virtually all officer contact with other individuals in both audio and video. Statistics from the U.S. Department of Justice show that in 2016, nearly half (47%) of the 15,328 general-purpose law enforcement agencies in the United States had acquired body-worn cameras.

Some of the top reasons why body cameras are recommended for police departments are increased safety for both the public and the officers, improvement of police accountability and the protection of officers from false accusations of misconduct. People tend to behave better when they know that they are being filmed, leading to a decrease in violence. The cameras also work as an effective training tool as the footage can be used to train officers in dealing with difficult situations.

A budget amendment in the amount of \$181,195.16 is required from the General Funds balance 101-000-699.000 (Transfer from Prior Year Reserve) to the following account: 101-310-970.000 (Minor Equipment – Police Services).

Recommend Approval of the above stated purchase in the amount of \$181,195.16 as submitted. I do not believe any further benefit will accrue to the city to seek further competitive bids. I respectfully request that you approve this budget amendment and purchase request.

If the purchase is approved, a signature from City Administrator Bruce Smith will be required on the End User License Agreement.


