# City Council Excerpt 10-07-19



Motion by Shetler, seconded by Bryant, regarding **2019/20 Non-Union Employee Compensation**, that the City Council approve salary adjustments for the non-union employees (16 full-time, 7 part-time) as was done last year and previously as follows:

- 1. Effective July 1, 2019, approve a 2.5% wage increase, excluding appointed officials, for full-time and permanent part-time employees who have been in their current positions for twelve or more months;
- Approve for all non-union employees who have been employed by the city for twelve or more months, including appointed officials, a service loyalty payment of \$300.00 for full-time employees and \$150.00 for permanent part-time employees, less appropriate payroll taxes;
- 3. A continuation of five (5) unpaid furlough days, two (2) of which have passed (July 5, 2019, and August 30, 2019) and, with the remaining three (3) furlough days of fiscal year 2019-2020 scheduled as follows:

#### Furlough Days Fiscal Year 2019-20

January 20thMartin Luther King Day;April 13thEaster Monday;May 22ndFriday before Memorial Day.



Pursuant to the collective bargaining agreements currently in place (July 1, 2019 through June 30, 2022) between the City of Grosse Pointe Woods and Technical, Professional, Office Workers Association of Michigan (TPOAM), the annual salary increase for these employees is set at an increase of 2.5% annually. There is no language in this contract which includes a service loyalty payment.

SUBJECT:	Fire Apparatus Financing
SUBJECT:	

Pursuant to the fiscal year 2020 - 2021 budget process, the budget was adopted based upon the option of financing \$500,000, respectively, the remaining balance of the fire apparatus purchase after the motor vehicle fund balance covered the first 50% of the cost. The anticipated delivery date of the apparatus is October 1, 2020.

I have been in contact with two different financing sources, REV Financial Services and Comerica Leasing. With the current interest rates being relatively low, the City has been offered the option of borrowing the money, prior to taking delivery of the truck in order to maximize interest savings. The process requires that the \$500,000 remain in an escrow account with the funds to be released upon receipt of the apparatus. During the budget process, we anticipated that interest expense for this financing option would be approximately \$42,000; I have since had discussion with both financing sources and learned that pre-payment of the first payment, at the time of closing will decreasing our interest expense by approximately \$19,000. Interest charges will accrue from the time period of the loan closing through the date of the apparatus delivery, with an estimate of those interest charges represented below. Attached are two amortization schedules summarized below as follows:

I would request the Committee-of-the-Whole recommend to Council to authorize City Administration to move forward with securing the financing prior to delivery of the equipment in order to maximize interest savings and authorize the pre-payment of the first principal payment on the closing date of the loan.
