Certification of Board of Election Inspectors

The undersigned, members of the Election Commission of the City of Grosse Pointe Woods, for the *November 6, 2018, State General Election,* do hereby certify the following:

- 1. The number of members of the Board of Election Inspectors shall be seven (7) in each precinct, seven (7) in each of two absent voter counting boards; one (1) of whom shall be designated as Chair, and one (1) of whom shall be designated as Co-Chair. One additional Inspector may be appointed to some precincts as needed.
- 2. The flat rate compensation for all regular precincts and absent voter counting board(s) shall be as follows:

\$175.00	Chair
160.00	Co-Chair
135.00	Inspector
90.00	Intern

- 3. If necessary, the City Clerk is authorized to appoint Election Inspectors to vacancies on the Board of Inspectors due to refusal or failure to serve. There shall be at all times during the times the polls are open a majority of Board of Election Inspectors on duty and there shall be at least one from each major political party: Republican and Democrat.
- 4. The number of members of the three Receiving Boards shall be six (6) total. The flat rate compensation for all receiving board members shall be \$50.00.
- 5. The members of the Board of Election Inspectors and Receiving Board for the above election are listed on the attached summary.

Dear Mr. Constantiello:

I write in my capacity as City Attorney for Grosse Pointe Woods after discussing the recent problems with the scanners with Grosse Pointe Woods City Clerk Lisa Hathaway. Ms. Hathaway has been attempting to obtain a resolution since Election Day. Although Dominion has agreed to refund the cost of the scanners, this issue remains unresolved.

I have reviewed several emails relating to the problems that occurred with use of the M160 scanners at the primary election held on August 7, 2018. We are also aware that 9 out of 9 communities in Wayne County that purchased the same scanners have experienced problems with its functionality and are all awaiting a resolution. I have also reviewed the three quotes from Dominion for new equipment and software from Kelly Garrett to Lisa Hathaway dated September 20, 2018.

Based on the licensing agreement and the State contract, the equipment is defective and should be fixed at no additional cost to the authorized user (Grosse Pointe Woods) pursuant to page 30 of the State contract. Rick Rivera, Dominion representative, was actually on-site at Grosse Pointe Woods on the night in question and witnessed the malfunction, so Dominion had notice of the defect on that date. Subsequent emails from Lisa Hathaway made clear that the equipment was defective. The City of Grosse Pointe Woods, and other authorized users, expect the machines to work as warrantied. The City should not be obligated to expend additional funds for software upgrades, nor to use the M160's for the November election.

The City is forced to make a decision to assure the integrity of the election process in the next few days. As Clerk Hathaway intends to purchase the larger M1130 scanners from an alternate source due to cost, Dominion should be providing the City with upgraded software to operate the new M1130's (3) at no additional cost to replace the defective and insufficient equipment, . Mr. Constantiello, we are requesting your immediate attention to this issue and will be contacting Wayne County and the State of Michigan to follow up on previous emails regarding this matter.

The City should not be held hostage on the eve of a major election based on almost new equipment malfunctioning during the August primary. We hope this matter can be resolved in the very near future.
