The meeting was called to order at 7:34 p.m. by Chair McConaghy.

Discussion ensued regarding the **2014/15 Budget**. The Treasurer/Comptroller provided an overview of a revised Fiscal Forecast that included privatizing emergency medical services. The Headlee rollback will be calculated after March Board of Review. Future revenue from Medstar's leasing of the ambulance and EMT quarters, as well as parking meters was not included in the forecast.

Discussion ensued regarding the poor condition of the City streets and the upcoming bond proposal. The Treasurer/Comptroller also stated additional revenue will be earned in the future from Briarcliff project property taxes.

FINANCE COMMITTEE 03-24-14

Administration will look at costs to provide services to residents Provencal/Colonial in comparison to payments made to Grosse Pointe Farms and Grosse Pointe Shores. The City Administrator will discuss the matter with Shane Reeside, and provide a recommendation whether Grosse Pointe Woods should take over all of the services provided to those residents.
