The first item discussed was regarding Life and AD&D Insurance. Mr. Apel provided an overview regarding Mutual of Omaha Life and AD&D Insurance benefits for current and previously retired employees, and he distributed information entitled City of Grosse Pointe Woods Life and AD&D Benefit Summary. The cost is \$198 per month. Questions and answers ensued.

Motion by McConaghy, seconded by Ketels, that the Committee-of-the-Whole recommend to City Council to renew the Life and AD&D Insurance policy with Mutual of Omaha at a total cost not to exceed \$13,087.80 per year for a two-year period commencing November 1, 2016.

Next, **Ghesquiere Park Batting Cages** were discussed. Member Ketels stated that batting cages are locked and therefore not accessible by residents, and a sign is posted stating the cages are the property of Little League. There was a consensus of the Committee that the cages need to be available to residence. The Clerk distributed a City Council excerpt from the October 1, 1990, meeting bringing attention a portion of a motion that an approval for installation of the batting cages was contingent upon Little League permitting use of the equipment by the residents:

8. RE: Request to Install Batter's Cages at Ghesquiere Park, that such installation BE AUTHORIZED with the following stipulations: that such facility will be locked when not in use; that resident use is allowed with proper supervision and equipment; that a \$1,000,000 insurance policy be provided the City by the Grosse Pointe Woods/Shores Little League; and that the City of Grosse Pointe Woods would be an additional insured.

Discussion included implementing a procedure enabling residents access to the cages, including which department manages the key to the cages - the Community Center or Department of Public Safety, initiate a key checkout procedure, determine an age for permitted use or require supervision in the cages, require periodic inspection of batting cages, adoption of policy guidelines, consider age restrictions, set gear requirements, and identify a number of people to be permitted in the cages at one time.

Discussion included using park passes for access to the cages, limit to two people inside the cages, managing the key through the community center and/or public safety, establish 13 years of age the same as the Activities Building, take a copy of the park pass in case of damage, increase the age limit or provide a drivers license, or be accompanied by an adult.

The Recreation Supervisor stated a park pass can be scanned the same as the procedure used for the basketball courts and that public safety can use the program too for times the Community Center is closed. She suggested identifying specific days/times for resident use. The Director of Public Services concurred to permit residents' use of the equipment, permit use with supervision of an adult, and possibly older than 13 years of age, dispatch is a good idea, and to copy the park pass.

The City Administrator suggested installation of a camera directed specifically at the cages. He stated that the cages are small and the policy needs to identify an age that would permit batting in the facility. The City Administrator was asked to obtain a cost for a camera.

There was a consensus of the Committee to ask that administration prepare Batting Cages Policy and Guidelines for review by the Committee as well as Little League, and that this item return to the Committee-of-the-Whole in a couple of weeks.

Discussion then ensued regarding **Ghesquiere Park Tennis Courts**. The Mayor provided an overview regarding the poor condition of the tennis courts, weeds, gathering of teenagers, and cost to repair. Discussion ensued regarding removing them. The Director of Public Services stated the cost to remove the courts, would be approximately \$11,500.00: utilizing City staff estimated costs are \$4,000.00 for removal, \$6,500.00 for topsoil, and \$1,000.00 for seed. The estimate to replace the tennis courts was between \$200-300,000. It was stated that removal work would be required even if courts are replaced and, minimally, clean up is necessary. Administration was asked to obtain prices to replace one, two, and four tennis courts. Director Schulte stated weather permitting, his crew could remove the courts in December and seed in the spring. This item is to remain on the Committee-of-the-Whole, and prepare for the City Council meeting on November 7, 2016, the first meeting in November.

The Committee then discussed **boat well vacancies** — **increasing size of some small wells.** The Mayor stated there are a number of small boat wells and asked the Committee if they wish to consider larger wells to attract larger boat owners. The Director of Public Services stated our channel is 47', which compares to Grosse Pointe Shores at 47' and 35 x 16 wells. The Park Supervisor's concern was that some boaters have been in the same wells for many years, and would it be permitted to allow a smaller boat to remain in a big well if someone chooses to pay a larger well fee. The marina would lose eight wells if increasing the well sizes to 32x15. 70 wells are currently not being used.

Following discussion, administration was asked to provide information including cost to increase well sizes, maneuverability and recommendation regarding such including feasibility and cost effectiveness, possibly reducing small well price, and identify other possible uses for the small wells. Administrative recommendations and additional information is to be readdressed within 30 days. This item is to remain on the Committee-of-the-Whole.

The next item discussed was regarding the Treasurer/Comptroller Vacancy. The Mayor provided an overview stating at the previous Committee-of-the-Whole meeting there was a consensus of the Committee to extend an offer of employment to a candidate contingent upon receipt of positive reference checks. The City Clerk and City Administrator performed the reference checks and all came back positive. There was a consensus that the Mayor will call the applicant with a proposed salary as discussed at the October 3, 2016, Committee-of-the-Whole meeting, and the City Attorney will meet with her to work details of the Employment Agreement. out appointment/Agreement would then be placed on the Council agenda for approval. There was a consensus of the Committee to move forward as discussed.

New Business:

- The City Administrator discussed implementing Halloween hours from 5:30 p.m. to 8 p.m. There was a consensus to move forward with Halloween hours.
- The Mayor stated a Compensation & Evaluation Committee Meeting was held earlier this evening. He provided an overview of recent increases awarded to non-union salary staff, TPOAM union members, and Public Safety, who received

a 2% increase plus a \$500 stipend. The City Administrator, Director of Public Services, and Director of Public Safety were recently appointed and did not receive additional compensation, nor did the City Attorney. The City Clerk's compensation was discussed and the Committee will be recommending to the City Council approval of a 2% pay raise and a one-time \$500 stipend retroactive to July 1. This recommendation will be addressed at the October 17, 2016, Council meeting.

Purchase of Two Public Safety Patrol Vehicles and Equipment

I am requesting that the City approve a purchase of two (2) new vehicles to replace the aging 2004 GMC pick-up truck currently in use by our Animal Control Officer as well as the aging 2008 Ford Crown Victoria used by the Detective Bureau. Our current patrol fleet consists of eight marked vehicles. The department would like to purchase a 2016 GMC Sierra 1500 regular cab for the Animal Control Officer and a 2016 Chevrolet Impala 4-door sedan for the Detective Bureau. These vehicles are the best options for the department when considering the other vehicles on the market in the same category. The vehicles will be purchased through Red Holman Buick GMC in Westland at a municipal price. Red Holman Pontiac has the state bid and is the vendor that our Department of Public Works has been using for their vehicle purchases.

In addition to the purchase of vehicles, vendors have been secured for the vehicle equipment and build out.

The costs include all required equipment, installation of that equipment, and striping of the cars. Canfield Equipment in Warren, and Majik Graphics in Clinton Township are the chosen vendors for this work due to their workmanship, location, and price.

The in-car mobile radios will be purchased from Motorola Solutions, the sole provider, in order to abide by State of Michigan specifications.

In addition, Stop Stick kits will be purchased from Stop Stick, Ltd. in Harrison, Ohio. These kits will be utilized by current vehicles in the department so that they may be equipped with the required tool for use when applicable with apprehension/pursuit termination. The department currently has only three vehicles equipped with the Stop Stick kits. There are often instances the equipped vehicles are out of service and/or unassigned as well as unavailable due to location at the time of an incident. It is the goal of the department to equip the entire patrol fleet with Stop Sticks. For consistency with equipment, training and departmental policy, the vendor will remain the same.

Those not recommended for further use by other departments due to mechanical condition will be auctioned off on the Michigan Intergovernmental Trade Network (MITN) website.

The vehicles rotating out of the fleet for replacement are as follows:

Animal Control Vehicle 50-19 @ 173,199 miles Detective Bureau Vehicle 5-11 @ 71,868 miles

Although Vehicle 5-11 has only 71,868 miles, it is in poor condition and is not reliable for driving outside of the city.

This will be a budgeted expense in the amount of \$62,600.70 included in the 2016/2017, 2017/2018, 2018/2019, and 2019/2020 budgets. The additional cost for the purchase of the Stop Sticks at \$1,843.00 is also included in the 2016/2017 budget although the actual cost will be \$11.00 higher due to a slightly higher than anticipated cost increase.

At the end of the 4-year lease period, the city will purchase each vehicle for \$1.00.

Budgeted amounts in the 2016/2017 fiscal year are: \$15,750.00 in account 640-852-977.349 for a one year lease payment for Public Safety Department vehicles.

Recommend Approval of the above stated lease/purchase with a cost not to exceed \$64,454.70 as submitted. I do not believe any further benefit will accrue to the city to seek further competitive bids.



The Claims billed to Group include both service-based and value-based reimbursement to health care providers. Group acknowledges that BCBSM's negotiated reimbursement rates include all reimbursement obligations to providers including provider obligations and entitlements under BCBSM Quality Programs. Service-based reimbursement means the portion of the negotiated rate attributed to a particular health care service. Value-based reimbursement is the portion of the negotiated reimbursement rate attributable to BCBSM Quality Programs, as described in Exhibit 1 to Schedule A. BCBSM negotiates provider reimbursement rates and settles provider obligations on its own behalf, not Group. Group receives the benefit of BCBSM provider rates, but it has no entitlement to a particular rate or to unbundle the service-based or value-based components of Claims. - 13 . BCBSM will charge an additional administrative fee if an ASC customer obtains stop-loss coverage from a third-party stop-loss vendor. The additional fee will be \$6.00 per contract per month.

The administrative fee is withheld from the rebate payments received from BCBSM's rebate administrators.
