MINUTES OF THE ELECTION COMMISSION MEETING OF THE CITY OF GROSSE POINTE WOODS HELD BY ZOOM ON WEDNESDAY, AUGUST 26, 2020.

The Chair called the meeting to order at 10:00 a.m.

Discussion ensued regarding **polling locations**. The City Clerk recommended retaining the polling locations for November the same as they were temporarily approved for the August election as outlined in her memo dated August 20, 2020. Members Gafa and Berschback concurred with the recommendation stating reasons such as avoiding voter confusion by not changing polling locations and the ability to administer elections in fewer polling locations (with the same number of precincts) due to the rise in absentee voting.

Motion by Gafa, seconded by Berschback, regarding **polling locations**, that the Election Commission recommend the City Council approve permanently establishing the city's precincts as approved for the August 2020 election, as follows:

- Precinct 1 Mason School 1640 Vernier Road (Formerly Ferry School)
- Precinct 2 Mason School 1640 Vernier Road
- Precinct 3 Community Center 20025 Mack Plaza (Formerly Parcells School)
- Precinct 4 Community Center 20025 Mack Plaza
- Precinct 5 Barnes School 20090 Morningside Dr. (Formerly Monteith School)
- Precinct 6 Barnes School 20090 Morningside Dr.

Hearing no objections, the Chair discussed the following items under New Business:

- Reimbursement for the March 2020 election was reported by the State to be direct deposited into the City's account by September 8, 2020, in the amount of \$30,000.00;
- The state is offering reimbursement for pre-stamping absent voter ballot return envelopes and related costs for the November 2020 election. The Clerk stated figuring an approximate cost for stamps at 65% of the registered voters (14,227) the estimated cost for stamps is \$4,700.00; this is not a budgeted item.

Motion by Gafa, seconded by Berschback, that the Election Commission recommend City Council approve pre-stamping absent voter ballot return envelopes for the November 2020 election, related costs to be reimbursed by the State of Michigan.

SUBJECT:	Polling Locations

In recent communications with Gary Neihaus, Superintendent of the Grosse Pointe Public Schools, he has agreed to continue providing Mason and Barnes school gyms as polling locations for four of the City's precincts. Due to construction in four of the precinct gyms, Council approved consolidating two precincts into three polling locations at the Community Center, Mason, and Barnes for the August 2020 election.

I recommend making these polling locations and precincts permanent for the following reasons:

- 1. No complaints were received from voters;
- 2. It takes less DPW man-hours to set-up and break down the precincts at three locations versus six;
- 3. It takes less time for Clerk's staff to set-up, and to perform rounds and troubleshoot at the precincts on Election Day by utilizing three locations versus six;
- 4. Due to the rise in absentee voting and decline in in-person voting, managing voter numbers in two precincts within one polling location is controllable from both health (COVID-19) and election administration perspectives. (Note: As reported by the precincts during the August election, the maximum number of voters in line were two.)

I recommend permanently establishing the city's precincts and polling locations as follows:

- Precinct 1 Mason School 1640 Vernier Road (Formerly Ferry School)
- Precinct 2 Mason School 1640 Vernier Road
- Precinct 3 Community Center 20025 Mack Plaza (Formerly Parcells School)
- Precinct 4 Community Center 20025 Mack Plaza
- Precinct 5 Barnes School 20090 Morningside Dr. (Formerly Monteith School)
- Precinct 6 Barnes School 20090 Morningside Dr.

SUBJECT:	Prepaid Postage for AV Ballot Returns/Budget Amendment

The State of Michigan is providing reimbursement for Municipal Clerks to provide prepaid postage on return absent voter envelopes, and related costs, when issuing an absentee ballot to voters for the November election. There is a sufficient supply of return envelopes on hand to run through the postage machine, a State approved process. The Election Commission, at their meeting held August 26, 2020, made a recommendation to the City Council to approve prepaid postage on absent voter ballot return envelopes. The cost for the postage, anticipating 65% (9,248) of total registered voters (14,227) voting by absentee, at .50 each, is estimated at \$4,624.00. Additional reimbursement-qualified costs will include postage meter ink and wear and tear on the equipment. This is not a budgeted item and will require a budget amendment.

I request the City Council concur with the recommendation of the Election Commission at their meeting held August 26, 2020, and approve a budget amendment to cover the cost of pre-paid postage on absent voter ballot return envelopes in the amount of \$5,000.00 from the prior year Fund Balance Account No. 101-000-699.000, into the City Clerk's Election Account No. 101-215-731.000, funds to be reimbursed by the State of Michigan.
