COUNCIL MEETING REPORT:

Due to budget constraints, the Council ended the ice skating program at Liggett; the Council will also address other budget cuts due to declining revenue.

BUSINESS AND REPORTS:

Perch Derby—June 20, 2009:

M. Sharp will obtain hot dog buns, paper products and T-shirts; B. Babcock will obtain hot dogs; B. Babcock and J. Dansbury will obtain the prizes. T-shirts will be donated.

Platform Tennis—expenses for continued operation of platform tennis were analyzed. Cost to repair the courts is estimated to be \$8,500. Cost to heat the courts is estimated to be \$4,000 per season. Courts are in usable condition, but will require maintenance in the future. Commission discussed possible user fee for platform tennis. City of Grosse Pointe charges \$50 annual fee for residents and \$100 for non residents.

- d. Bath house will be closed for 6 months (fall and winter). Employees currently stationed at bath house will re-locate to city hall
- e. Pool hours will be shortened from Memorial Day to June 11; regular hours to resume when school is out for the summer.
