Harbor Overnight Registration Form

Harbor Rules and Regulations for overnight sleeping on boats:

1. Reservations are required. Canal entry by non-registered boaters after the park is closed will not be permitted. Non-compliant boaters will be escorted from the park.
2. No owner may sleep overnight more than two consecutive nights.
3. The boat must have an enclosed sleeping area and bathroom facilities.
4. The number of people sleeping on the boat must not exceed the maximum number of sleeping berths as indicated by the owner's manual or as determined by the Park Supervisor.
5. The boat owner must be present for the entire night.
6. Those sleeping on the boat (including dogs) must remain on board while the park is closed 11:00 p.m. through 6:00 a.m.; Entries or exits to or from the park will not be permitted once the park closes.
7. Any excessive noise (regardless of the time) may be cause to revoke the overnight sleeping permit.
8. Any resident sleeping on a boat for purposes of reserving a picnic area the following morning is required to wait in line at the front gate.
9. Any violations will result in a loss of overnight privileges and may result in the loss of boat well mooring privileges.
10. Domestic animals are not permitted entry to the park unless they have been registered and licensed through the park office.
11. The boat storage permit holder shall be responsible for the conduct of his guests, employees, invitees, and all persons using, visiting, or occupying the boat. The permit holder shall indemnify the city of Grosse Pointe Woods and its agents and employees against any claim by himself, the boat owner, his guests, or others for injuries, claims, or any damages arising as a consequence of the registered boat's presence in the boating facility or on account of the presence of the permit holder, boat owner or any of his guests or others in the boating facility.
