The Building Official provided an overview, which included the neighboring Grosse Pointe communities ordinances, and he requested direction from the Planning Commission as to what additional information the Commission may need to consider any changes to the Zoning ordinance.

Following discussion, there was a consensus of the Commission to schedule a workshop on September 27, 2011, prior to the regular Commission Meeting. The Chair stated he would prepare a report based on tonight's discussion for further discussion at a workshop and asked the Building Official to provide additional information regarding regulations, property values, and comparables.

The Building Official provided his Monthly Report:

- A meeting was held with the developers of The Rivers to discuss progress. It was reported that interest has been shown in the condominiums, which will be at a cost of approximately \$190,000, developers are beginning to bid out aspects of the project, digging will begin in January, and developers are reviewing for TIFF Brownfield.
- Rodent problems were reported on Cook. The Building Department will distribute informational packets.

Commissioner Vaughn gave a report to the Commission on City Council action taken at their meetings on August 1, 2011, and August 15, 2011.

Under New Business, the following items were discussed:

- 2020 Plan Committee: Commissioner Hamborsky will schedule a meeting for next month. Wednesday, September 14, 2011, at 7:45 p.m. was proposed.
- Business and Development Committee: Commissioner Evola gave an overview. She stated that efforts of the 2020 Plan and Business and Development Committees are duplicative and suggested combining the two committees.
- Special Sign Ordinance: No action taken.
- Council Member Ketels responded to the Chair's request for an update regarding Council candidates for the November 8, 2011, General Election.
- The Building Official provided an update regarding University Liggett's grade and water retention on the residential properties.
- The Chair announced the Grosse Pointe Woods Foundation is holding a fundraiser at the Grosse Pointe Yacht Club on September 8th, and he invited all to attend.
