Building Official Tutag opened the discussion stating that LEED Certification is rating system for new construction and major renovation governed by U.S. Green Building Council (USGBC) to promote environmentally friendly and energy efficient buildings. He stated that this program would be beneficial to the City in that it would promote an energy cost savings in the future, however, there may be a 1% to 2% increase in upfront construction costs. Building Official Tutag recommends the City follow the LEED Silver Standard. Discussion ensued among Commission Members regarding the program.
