Mr. Tutag also indicated that in Grosse Pointe Woods there are 13 homes in pre-foreclosure, 15 are up for auction and 25 are bank-owned homes. The Building Department keeps an eye on these properties to assure property maintenance is in compliance and we have also contacted previous property owners to maintain properties, or tickets are issued.
