Motion by, Evola, supported by Hames, regarding Site Plan Review, Peoples State Bank, 20276 Mack Avenue, that the Planning Commission APPROVE the proposed site plan with the following conditions:

- 1) All work in the right of way is approved and inspected by Wayne County Road Commission:
- 2) if the need arises, the land banked drive-up stacking shall be activated;
- 3) the concrete decorative block walls, as shown on the site plan detail, shall be bricked;
- 4) two colonial light fixtures be added to the front of the parking lot;
- 5) additional spruce plantings be added to shield headlights from residential areas;
- 6) roof details be worked out with the Architect and Building Official Tutag;
- 7) and the redesignated loading space be resubmitted on plans for approval.

The Cook School House will become a historical monument for the City of Grosse Pointe Woods for many years.

The next item on the agenda was regarding Continued Discussion of Dance Ordinance to Amend Chapter 98, Zoning Article VII C Commercial Business District, Section 98-203(4) Special Land Uses and Article VIII C-2 High Intensity City District, Section 98-242(1)(g), Permitted Uses, to Allow Establishments Licensed by the Liquor Control Commission to Obtain a Dance Permit and an Odinance to Amend Chapter 50, Liquor Control Ordinance, to Provide Procedures and Standards for Issuance of a Dance Permit.

At this time, City Attorney C. Berschback provided a summary of the September 25, 2006 Committee of the Whole discussion on the proposed dance ordinance.

A round robin discussion concluded with a suggestion that the Planning Commissioners visit Robusto's and other 'dancing establishments' in neighboring cities and do on-line research for dance ordinances in neighboring communities.
