- 3. The dumpster enclosure brick match that of the existing building and addition;
- 4. Incorporate the dumpster enclosure into the six foot high brick screening wall on the south, eliminating a dead area between the screening wall and dumpster wall;
- 5. Gate screening material used for the dumpster enclosure is subject to approval of the Building Inspector;
- 6. Compliance with the Director of Public Safety's requirements for floor plans, egress, and exit and emergency lighting as indicated in his memo dated September 19, 2005.

Defining an accessory building and/or garage.
Using a gradual scale with proportion to lot size.
Garage height should not exceed the height of the home.

Building Official Tutag and Assistant City Attorney Berschback will meet and compose a draft. The draft may be presented at the October meeting for review.

The next item was concerning Verbal Report - **Building Official's Monthly Report.** Mr. Tutag reported on the following matters:

- Presently attending the International Code Council conference at Cobo Hall throughout this
 week and had a chance to confer with other inspectors around the country. Henry Green
 will be inducted this week as President of the International Code Council.
- The Mobile Station at Mack and Vernier has changed the white band around the canopy to a non-conforming blue, and then back to white again. The pumps have been changed and meet compliance with new state regulations.
- The St. John project continues and is moving along guickly.
- The progress at Sunrise Assisted Living II is phenomenal.
- The lighting store is now vacant and a new lighting store will be moving in shortly.

At this time, Chair Zolik apologized for skipping agenda item #9, concerning **Continued Discussion of Site Plan Review Ordinance**. Chair Zolik asked Assistant City Attorney Berschback to comment.

Mr. Berschback indicated this item was discussed earlier at tonight's Planning Commission Workshop meeting. Additional revisions to the Site Plan Review Ordinance were made. Mr. Berschback and Building Official Tutag will complete the final draft and may present it to the Planning Commission at next month's meeting.

The next item on the agenda was concerning **Verbal Council Report**, **September 12 - Richardson**, and **September 19 - Vaughn**:

Concerning the September 12th meeting, Commissioner Richardson indicated a setback variance was granted for 1536 Cook Road. Council suggested the Planning Commission review the setbacks in that neighborhood.
