Subject: Blade Sign Ordinance

Gene, I've been thinking about what our sign ordinance could contain with respect to blade signs. Other city ordinances on the Internet included some of the following restrictions:

- * Definition: Double-sided, perpendicular to building facade,
suspended from decorative bracket
- * Location: Allowed only in business district
- * Size: 6 sq.ft. max.
- * Position: >= 8' from grade, <= 3' extension from bldg. facade
Above window and below roof line, ex: over entrance
- * Number: Limited to one per business
- * Illumination: Lighting not permitted
- * Content: Name and/or logo only.
- * Color: Consistent with approved color palette or business logo

Perhaps if you have time to give this some time before our next meeting, we could get it on the March agenda.
