- The Rivers project is coming along nicely. They are putting in the elevator pits, stairwells, and will be starting on the masonry next week.
- Bellissima Boutique, a bridal shoppe, is moving into the Woods from the Hill.
- Spoke with two different parties that are interested in opening a cigar/martini bar on the Robusto's property.

Commission Member Stapleton was unable to attend the **January 28th Council Report** and Council Member Ketels did not recall anything of importance to the Commission.
