**3-5AM PARKING PERMIT APPLICATION**

**Criteria used to determine eligibility for RESIDENT's. Please Read the Following.**

1. A two-car garage counts as one parking space.
2. The number of registered vehicles **MUST** exceed the property's available parking.
3. Corner lots: the driveway approach counts as one space.
4. Permits will not be granted solely due to the inconvenience of moving (**Shuffle**) vehicles.
5. All vehicles must be registered to the applicant's address and listed on the application.
6. Copies of valid, current registrations are required at the time of application.
7. Only vehicles registered to your address will be eligible for a parking permit.
8. Homes with a City-Registered dog may receive consideration for a closed gate or fenced yard; proof of registration must be provided by Applicant.
