On behalf of the members of the Department of Public Safety, I am pleased to present to you, Mayor Robert Novitke, and the members of the City Council the Annual Report for 2013. Our Department has worked diligently during this past year to provide the best possible public safety services for the citizens of Grosse Pointe Woods. I am very proud of each and every one of our team members for their efforts, dedication, and courage.

Our department faces new and unexpected challenges on a daily basis. I have continued to focus on increasing area patrols and utilizing our Auxiliary officers to concentrate on monitoring vacant and foreclosed homes, and patrolling the business district alleyways. The Auxiliary bike patrol program has proven to be very effective and appreciated by the community.

As an approach to community policing and as a way to reach out to our youth, Detective Daniel Koerber, who maintains an office located in Grosse Pointe North High School, continues to be a liaison in our schools. He has been successful in interacting with the school administration and students. By developing this approach, I believe we have been able to successfully address current issues our youth are facing and better ensure safety within our schools. Our department is continuing to focus on school safety precautions in the hopes of preventing the tragedies which have struck other communities across the country.

In addition, our department has increased the use of NIXLE to disseminate information that is of public concern and to obtain assistance from the community in crime prevention.

Crimemapping is another tool that the department has implemented to educate the public on criminal activity which occurs throughout the year in different areas of the city. Historically, this tool has been used by law enforcement agencies to focus patrols and surveillance in areas of increased criminal activity.

Our statistics for the year 2013 include 208 Index and 385 Non-Index crimes, a total of 593 crimes, which represents a decrease of 14 percent from the 689 crimes reported last year. I was pleased to see the reduction in crime and attribute that to the implementation of increased patrol activity by our Public Safety and Auxiliary officers. It was also encouraging to see larceny, which has historically been our highest index crime, also decrease by 17 percent. There were 140 reported larcenies in 2013 in comparison to the 169 reported in 2012.

There were 14 actual fires with a fire loss of \$238,750 in 2013 in comparison to the 15 actual fires with a fire loss of \$140,000.00 reported in 2012.

In 2013, we had 19 auto thefts, 27 less than the 46 reported in 2012. Only one stolen vehicle was taken from the St. John's Hospital parking lot in comparison to 23 last year. This decrease was largely due to the special attention that St. John's security has been giving to the north parking lot area as well as increased patrols by Grosse Pointe Woods Public Safety officers

As we move forward into the future, the Department of Public Safety is excited for the opportunity to embrace whatever challenges may arise. We are continually improving our processes so that we can act quickly to provide our community with the high level of service they deserve. Every situation is important to us whether it is the protection of our young and innocent children in school, a business owner in need of assistance, an elderly resident in need of the friendly reassurance of a daily phone call from our dispatch staff, rescuing those who are trapped in a burning building, maintaining the safety of those who drive on our roads, or helping a stray dog who has lost his way home.

I am proud and honored to serve as the Director of Public Safety for the City of Grosse Pointe Woods and look forward to years of continued service. I will lead the Department in a professional and courteous manner to the best of my ability.

I would like to thank Mayor Novitke, members of the City Council, and all of the citizens we serve for your continued support in our mission to maintain the safety and improve the quality of life in the City of Grosse Pointe Woods.

INTRODUCTION

Each year, the Grosse Pointe Woods Department of Public Safety prepares an annual report of crime statistics for the City of Grosse Pointe Woods, the Michigan Incident Crime Reporting (MICR), and the Federal Bureau of Investigation Uniform Crime Report (UCR). This data is compiled from offenses reported to the Department of Public Safety, monthly police reports, and individual crime incident reports.

The primary objective of this annual report is to provide a reliable set of criminal justice statistics for police administration, operations, and management. The localized study of crime data enables personnel to assess the influence of crime in areas, neighborhoods, and people. Similarly, crime statistics permit analysis among neighboring jurisdictions and with those of similar populations and other characteristics. A broad examination of the crime data allows individuals to view the nature and movement of crime, underlying changes, and fluctuations throughout the City of Grosse Pointe Woods, the State of Michigan, and the United States.

The Department of Public Safety is committed to improving the reliability and validity of our crime reporting data. We are attempting to achieve this goal by study and analysis of major crime indexes and understanding the impact of classification revisions mandated by the State. As a result, some offense categories have decreased, while others have increased. Our efforts are to provide a reporting system that will be more accurate, valid, reliable, and compatible with State and Federal standards.



SPECIAL RECOGNITION

Although each and every one of our officers has made significant contributions to the Department of Public Safety, there are two officers who were given special recognition for outstanding achievements.

Public Safety Officer Brian Conigliaro received a Department Commendation in recognition of his tenacious work ethic, alertness and prompt action on July 24, 2013 when he was instrumental in the arrest of four suspects charged with larceny. Officer Conigliaro was on routine patrol when the Department received a 911 call regarding the strong armed robbery of a female in the parking lot of a grocery store. Upon searching the area, he observed a vehicle with four occupants on a nearby street and stopped the vehicle. With the assistance of Officer Matthew Muzia and Sergeant Joseph Cardosi, the trio was able to establish that the occupants were involved in the crime. The suspects were arrested with the assistance of units from Grosse Pointe Woods and other neighboring departments. Without the actions of Officer Conigliaro, the suspects would not have been apprehended and would still be at large in the community.

A Department Commendation was also received by Officer Walter Galat in recognition of his alertness and prompt actions on July 29, 2013 while on routing patrol when the Department received a 911 call regarding the larceny of a mountain bike from a garage. Officer Galat located and apprehended a suspect riding a bike which matched the description of the stolen property. The suspect was carrying a small lawn tiller which was later identified as stolen property from another nearby garage. Without Officer Galat's alertness and prompt actions, the stolen items would not have been returned to the victims and the suspect would have remained at large.

Officer Daniel Marietta was honored at the 31st annual Respect for Law Program sponsored by the Lakeshore Optimist Club held on May 1st, 2013 at the Lochmoor Club. Marietta was recognized at the ceremony for the field interview he conducted on June 26, 2012 with three suspects who were subsequently arrested and charged with possession of stolen property. 


EMERGENCY MEDICAL SERVICES



The Department operates an Advanced Life Support ambulance staffed by five Paramedic/Firefighters: Mark Bletch, Anthony Calappi, Wayne Culver, Charles Krantz, and Corey May. These five staff members work a 24-hour, 3-platoon system.

A public safety officer assists two of the paramedics with every ambulance run. With enhanced technology and equipment, paramedics can begin advanced lifesaving procedures and transmit reports to area hospitals before the patient arrives. Electronic ambulance report writing and billing continue to be utilized by the Department. All of the patrol vehicles are equipped with an Automatic External Defibrillator (AED).



FIRE OPERATIONS

The Department prides itself on its quick response to all emergencies. In addition to the 14 dwelling fires in Grosse Pointe Woods, our firemen also responded to 10 other fires at or in single family dwellings, 5 commercial building fires, 3 vehicle fires, and 6 dumpster/outside fires. We also provided mutual aid to Harper Woods, Grosse Pointe Farms, and Grosse Pointe Shores. There were 23 fires in these communities requiring mutual aid in 2013. Fire Inspector Joseph Provost continued with our commercial business fire inspections.







DETECTIVE BUREAU


The Detective Bureau is the Criminal Investigation Unit for the Department. The detectives assigned to this unit are responsible for investigating all crimes committed against persons or property in the community. They are available to respond to a crime scene 24 hours a day. All detectives receive specialized training to develop and enhance their investigative skills including attending legal update training and meetings with detective bureaus from neighboring jurisdictions. The Detective Bureau is also responsible for monitoring businesses that possess a Michigan liquor license to ensure compliance with Michigan liquor laws.

The Grosse Pointe Woods Detective Bureau consists of Detective Kevin Bonk, Detective Anthony Chalut, Fire Inspector/Detective Joseph Provost, and Traffic Safety Officer/Detective Daniel Koerber. Together, these detectives are responsible for investigating crimes, collecting and preserving evidence, identifying perpetrators, interviewing witnesses, interrogating suspects, and preparing cases for successful prosecution. The Detective Bureau operates under the supervision of Lt. John Ross.



92% of the 813 Criminal Cases assigned to the Detective Bureau in 2013 are closed.

DETECTIVE BUREAU (continued)

Detective Daniel Koerber, the Department's Youth Officer, is responsible for any crimes and or violations involving persons under the age of 17. He has an office located at Grosse Pointe North High School and has become a direct liaison with school administrators, teachers, and students. Detective Koerber is an educator and mentor for all students in the Grosse Pointe School System. Detective Koerber is also responsible for traffic safety, overseeing crossing guards, conducting traffic and speed studies, and investigating traffic-related incidents as well as the community crime prevention program.

SPECIAL RESPONSE TEAM (SRT)

The Special Response Team (SRT) is a specially trained 12-member cross-jurisdictional law enforcement team which responds to potentially dangerous situations. The SRT executes search and arrest warrants, intervenes in hostage situations, works on counter-terrorism missions, provides perimeter security for high-profile events, and provides assistance in other high-risk situations.

In 2013, the SRT was activated on 9 separate occasions. These activations, which varied from fraud investigations, narcotic search warrants, homicide investigations, and barricaded gunmen, resulted in multiple arrests and recovery of stolen property and other paraphernalia.



DEPARTMENT TRAINING

Each year, officers train with the specialized rescue tools and fire equipment used by the Department. Members of the Department attended 345 hours of Police and Fire training courses at local colleges and other training facilities in 2013 and also participated in 1,407 hours of in-house training. The Department received a total of 1,752 hours of training in 2013.

ANIMAL CONTROL



The feathered and furry residents of Grosse Pointe Woods are grateful for the presence of our Code Enforcement /Animal Control officer, Debbie Reed. A 16-year veteran of the Department, Ms. Reed's days are filled with unexpected and unique situations. A typical day at work might involve rescuing a kitten from the inside of a car engine compartment, attempting to lure squirrels from hiding places under the roof at City Hall, sending bats in for rabies testing, etc...

One of Officer Reed's most memorable events during her career with the city is the story of a stray Akita she named "Ghost" because of the dog's ability to disappear within moments of being sighted. Ghost ran loose throughout the city for several years between Renaud and the northern city limits until it was adopted by a resident who found the dog and gave it a home. Officer Reed's marshmallow heart melted whenever she spotted the dog on a leash going for a walk with its new owner as she knew that the dog would have had quite a different fate had it been captured.

Officer Reed encourages all Grosse Pointe Woods residents to consider having their pets spayed or neutered to help increase the chances of the growing number of dogs and cats in shelters to find good homes.

In 2013, the Department responded to 546 animal control incidents.

CROSSING GUARDS

The parents of our community depend upon our Crossing Guard team for the safety of their children when walking or riding a bicycle on their route to school or home. No matter what the weather is, our team of dedicated guards is ready to guide and protect our children. We are deeply appreciative of their efforts.

AUXILIARY UNIT

The volunteer Auxiliary Unit is a vital resource for the Department. Not only do they assist officers at community events such as the annual fireworks and Fire Safety Open House, but they also provide assistance at fire scenes, perform fire hose testing protocols, and perform other essential duties.

The Auxiliary Unit underwent 199 hours of training and devoted 761 hours of service to the City of Grosse Pointe Woods in 2013. They are an indispensable part of our community.

POLICE CHAPLAIN



It has been a blessing for the Grosse Pointe Woods Public Safety Department to have had the guidance of Sr. Chaplain Major Dennis R. Walker for the past nine years. Chaplain Walker began his career serving the cities of Grosse Pointe Woods, Ferndale, and Madison Heights after a 35-year career in the automotive industry with the Chrysler Corporation. He felt the need to do something more with his life upon retirement and decided that a new career as a police chaplain would be the right choice after much soul-searching and prayer.

Chaplain Walker provides support and counseling to public safety officers in the areas of trauma, grief and loss, critical incident stress management, critical incident stress debriefing, depression, divorce, and death counseling.

Chaplain Walker's impressive credentials include the titles of Board of Director and President of the Oakland County Crisis Response Organization. He is also active in his church in Royal Oak where he serves as an Elder and visits home-bound and hospitalized parishioners. His military career includes over three years of service with the United States Air Force where he was stationed in Vietnam. Chaplain Walker was also a member of the Royal Oak auxiliary police team for 18 years. In addition, he has held various positions with the Boy Scouts of America and the Lamphere High School Band Boosters. The Grosse Pointe Woods Department of Public Safety is very grateful for the continued presence of Chaplain Walker in their lives.

REGIONAL COOPERATION EFFORTS

MEMORIAL TRIBUTE



The Department of Public Safety lost a valued team member in 2013 when Raleigh, our local police K9 unit, passed away at the age of nine. Raleigh, an 80 lb. German Shepherd trained by Grosse Pointe City's Sergeant Michael Almeranti, had served Grosse Pointe area cities for seven years. He had earned numerous awards and citations for his work which included the accomplishments of 305 narcotics recoveries, helping to locate 59 perpetrators for crimes such as arson, home invasion, armed robbery, stolen vehicles, and fleeing and eluding the police as well as helping to locate 6 perpetrators found hiding in buildings during searches. Raleigh grew to be loved by the community during 145 appearances at schools, parades, and other civic events. He was also highly valued in our local school system as he assisted in 52 locker sweeps.







COMMUNITY INVOLVEMENT

The staff of the Grosse Pointe Woods Public Safety Department has often devoted their time and efforts to helping to improve the lives of the members of the community around them. The Department helps both the young and the old by hosting educational tours of the department and its facilities to local youth groups and schools and by improving the safety and well-being of homebound senior residents by having the dispatchers call to check on their welfare in the mornings, Department members have also been involved in events and programs which include the Special Olympics for the handicapped, donating coats and blankets to the poor, and participation in events such as Shop With A Cop where children have the opportunity to go on a pre-Christmas shopping spree with an officer at a local store. It is an honor and a privilege for us to serve and protect members of the community.

Residents who attend future community events and programs will have a good chance of seeing the department's treasured Humvee, a used Army vehicle which was acquired for the city at no cost through the efforts of Director of Public Safety Andrew Pazuchowski. A Humvee is a sturdy vehicle equipped with a diesel engine and is valued at \$50,000 if purchased new. Capable of driving through anything, the vehicle has already proven useful in major snowstorms. Because of safety issues, the vehicle will be used mainly by the Special Response Team and for display at special events to avoid taking a patrol car or emergency vehicle out of service.

Director Pazuchowski spent much time and effort going through the government's authorization process in order to obtain the vehicle but the efforts paid off in a big way as the city now has access to a variety of decommissioned items. Pazuchowski (pictured below) chose the best vehicle out of the available inventory. The Director used funds available from confiscated property in order to refurbish the Humvee before it could be put into service for the city.




INDEX CRIMES BREAKDOWN










