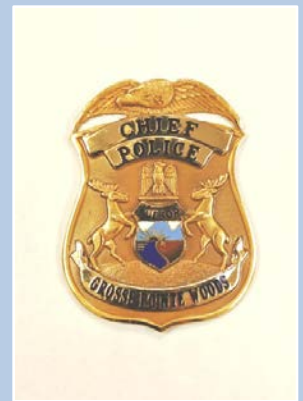

Dear Mayor and City Council,

On behalf of the members of the Department of Public Safety, I am pleased to present the Annual Report for 2014 showing the activities of the Grosse Pointe Woods Department of Public Safety. Our department has strived this past year to maintain a safe community, while at the same time, providing the best possible services to its citizens.

As a result of retirements this past year, we have taken the opportunity to reorganize the department to reflect these changes while still striving for and providing excellent customer service. I am proud to say that several promotions have taken place over the past year with seasoned veteran officers being promoted to the rank of Sergeant and one Sergeant being promoted to the rank of Lieutenant. Also this past year, our Director of Public Safety, Andrew Pazuchowski, retired after 29 years of service. We appointed Bruce Smith as our new Director at the Council meeting on February 2, 2015. Director Smith has a long and successful career in law enforcement spanning 37 years in total, including 25 years in a supervisory capacity.

In 2014, we experienced 568 Index and Non-Index crimes which represent a 4% decrease from the 593 reported last year. As in previous years, we continue to see larceny as the highest crime experienced in our community. We have had a decrease in reported cases from 140 in 2013 to 137 reported incidents in 2014.

This past year we experienced several hi-profile events atypical for this community. I am proud to say that the officers of this department responded with the highest level of professionalism in addressing these crimes. I am also grateful for the vision and support Mayor and Council have shown during these incidents.

In summary, I would like to address some of the more notable cases our department experienced this past year.

- During the months of August, September, and October of 2014, we experienced a rash of home invasions. Fortunately these incidents occurred during the daylight hours and all of the homes broken into were unoccupied. During this same time frame, the other Grosse Pointes were also experiencing home invasions as was the City of Harper Woods and the City of St. Clair Shores. Multi-jurisdictional cooperation with these other agencies in the sharing of information, undercover operations and surveillance resulted in the arrests of nine individuals responsible for these crimes. In one noteworthy home invasion, the family dog was also stolen but was rescued a day later and returned to the very grateful owner.
- We also had three bank robberies reported this past year, the first since 2011. Our detectives continue to work closely with the FBI and other agencies to resolve two of these outstanding cases. In the third bank robbery, the suspect was arrested only 13 minutes after committing the crime. His arrest was another example of the successful mutual aid agreement with the other Grosse Pointes and Harper Woods. Officers responding from the other communities under our mutual aid agreement flooded the area and were able to spot the responsible individual and arrest him.
- In October of last year through the cooperation of the Department of Corrections and our Detective Bureau, an investigation was launched into a drug operation out of a home in the city. Officers successfully shut down the operation, arrested the person responsible and recovered cash, weapons and drugs from a convicted felon.
- Also in October of 2014, officers responded to a report of a trench collapse with a victim trapped. While valiantly attempting to save the life of a trapped victim, an officer was injured in a secondary collapse. I am happy to report that he is expected to make a full recovery and return to work in mid-2015. This event tragically resulted in the victim losing his life in a secondary collapse. The recovery efforts for the victim were unprecedented in the history of the department. A 42 hour operation ensued to recover his body and involved several other agencies and rescue teams. Our personnel responded with professionalism and several officers were recognized for their heroic efforts in their attempt to save the life of the victim.

Auto theft has increased from 19 reported in 2013 to 22 in 2014. Only one stolen vehicle was taken from the St. John Hospital parking lot, the same as last year. This is due to the special attention given to the north parking lot area as well as increased patrol by Grosse Pointe Woods officers.

Larceny from vehicles is an on-going problem and is experienced throughout the Grosse Pointes. The department had 18 reported incidents of items stolen from vehicles as well as 15 reports of parts and accessories stolen from vehicles in 2014. Valuables left in plain view are an easy target for thieves. Citizens need to be vigilant and aware that it only takes seconds for criminals to enter a locked or unlocked vehicle to remove items. Residents are urged not to leave valuables in their vehicles and to always lock the doors of their vehicles and keep the windows closed.

This department continues to reach out to our youth. A seasoned detective who has an office in Grosse Pointe North High School continues to be assigned as a liaison in the schools. This officer has been successful in interacting with the school administration and students. By developing this approach, I believe we have been able to successfully address current issues which our youth are facing and better ensure safety within our schools.

In addition to our newly appointed Public Safety Director, Mr. Bruce Smith, another promotion to Sergeant took place in 2015 bringing our command staff levels within budget. Administration is also planning with Mayor and Council approval to implement a K-9 Unit in 2015. Through the very generous donation from the *K9 Safety Partners of the Grosse Pointes*, the K9 Unit is much closer to becoming a reality. As we move forward, several challenges await us. I am confident that the Department of Public Safety will rise to meet the challenges presented and to fulfill our mission. Our members will serve with distinction while making the best possible use of the resources available to us. We will continue to build upon and maintain productive partnerships with local governments and other organizations and continue to pursue excellence and to be efficient and accountable for our actions. Through our excellent work force and their expertise, we will provide our citizens with the level of service they are entitled to and certainly expect and deserve.

I am proud to have served as the City Administrator and the Acting Director of Public Safety for the City of Grosse Pointe Woods this past year and look forward to Director Smith's ability to continue to lead our community's professional Public Safety, Emergency Response, and Auxiliary personnel.

I would like to thank the Mayor and City Council for your vision in the support of the Public Safety Department and also all of the citizens we serve.

INTRODUCTION



City Administrator/Acting Director of Public Safety Alfred J. Fincham

Each year, the Grosse Pointe Woods Department of Public Safety prepares an annual report of crime statistics for the City of Grosse Pointe Woods, the Michigan Incident Crime Reporting (MICR), and the Federal Bureau of Investigation Uniform Crime Report (UCR). This data is compiled from offenses reported to the Department of Public Safety, monthly police reports, and individual crime incident reports.

The primary objective of this annual report is to provide a reliable set of criminal justice statistics for police administration, operations, and management. The localized study of crime data enables personnel to assess the influence of crime in areas, neighborhoods, and people. Similarly, crime statistics permit analysis among neighboring jurisdictions and with those of similar populations and other characteristics. A broad examination of the crime data allows individuals to view the nature and movement of crime, underlying changes, and fluctuations throughout the City of Grosse Pointe Woods, the State of Michigan, and the United States.

The Department of Public Safety is committed to improving the reliability and validity of our crime reporting data. We are attempting to achieve this goal by study and analysis of major crime indexes and understanding the impact of classification revisions mandated by the State. As a result, some offense categories have decreased, while others have increased. Our efforts are to provide a reporting system that will be more accurate, valid, reliable, and compatible with State and Federal standards.

MISSION STATEMENT



The Mission of the Grosse Pointe Woods Department of Public Safety is to continually strive to improve the safety and quality of life within our community. This will be accomplished through a broad based combination of traditional and innovative police, fire and emergency medical services while always protecting constitutional and basic human rights. 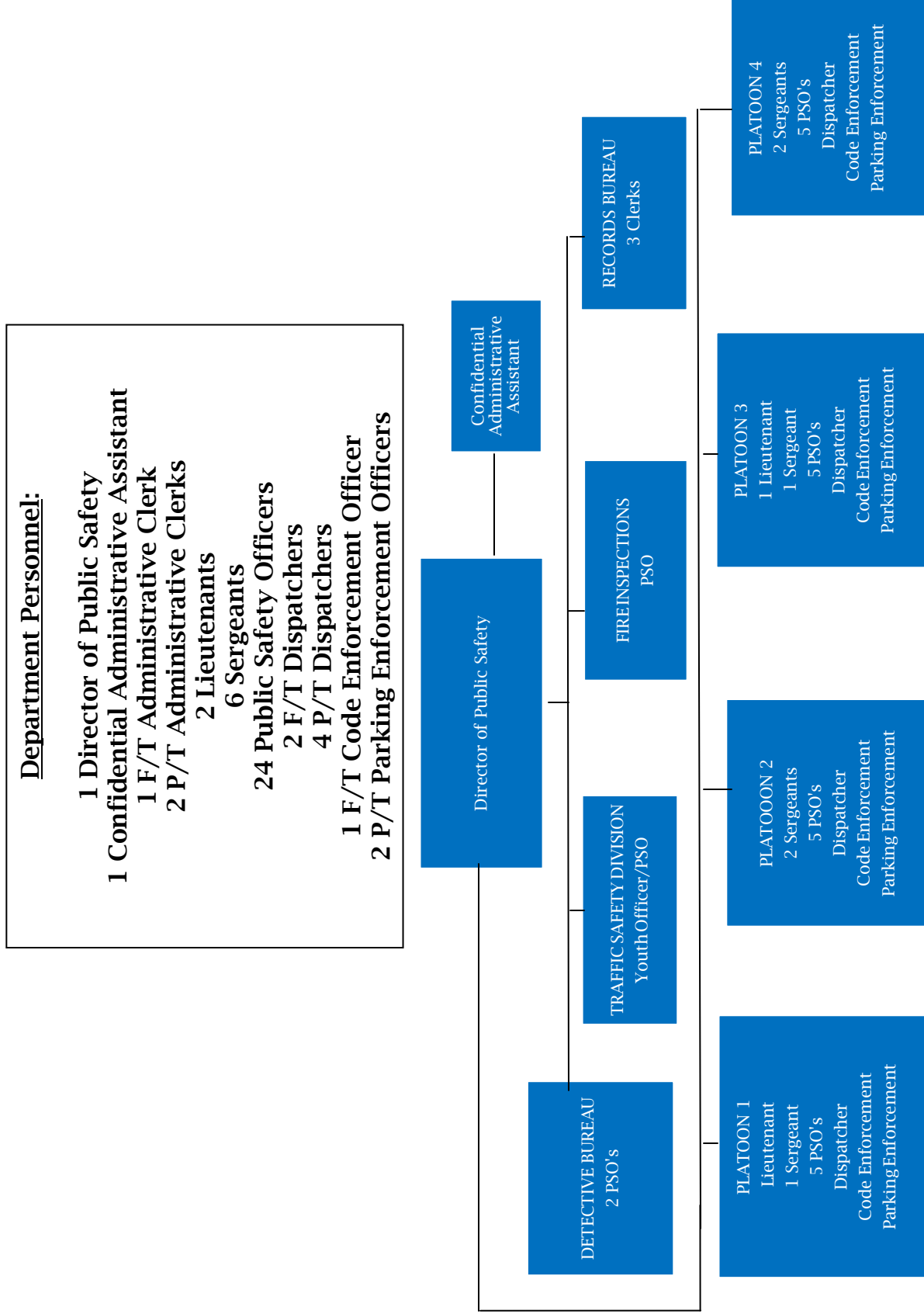

2014 will go down in history as one of the most significant and memorable years the Grosse Pointe Woods Department of Public Safety has experienced. A tragic trench collapse on October 29, 2014 claimed the life of the victim trapped inside despite the feverish efforts of department members to save him. Our officers were assisted by officers from other communities and counties in the three day recovery attempt. Officer Jeffry Martel was injured in an attempt to stop the falling debris from falling on the victim as falling rubble partially buried him. Members of our staff who were involved in the incident were honored for their bravery and courage at an awards presentation during the City Council meeting on November 17, 2014.

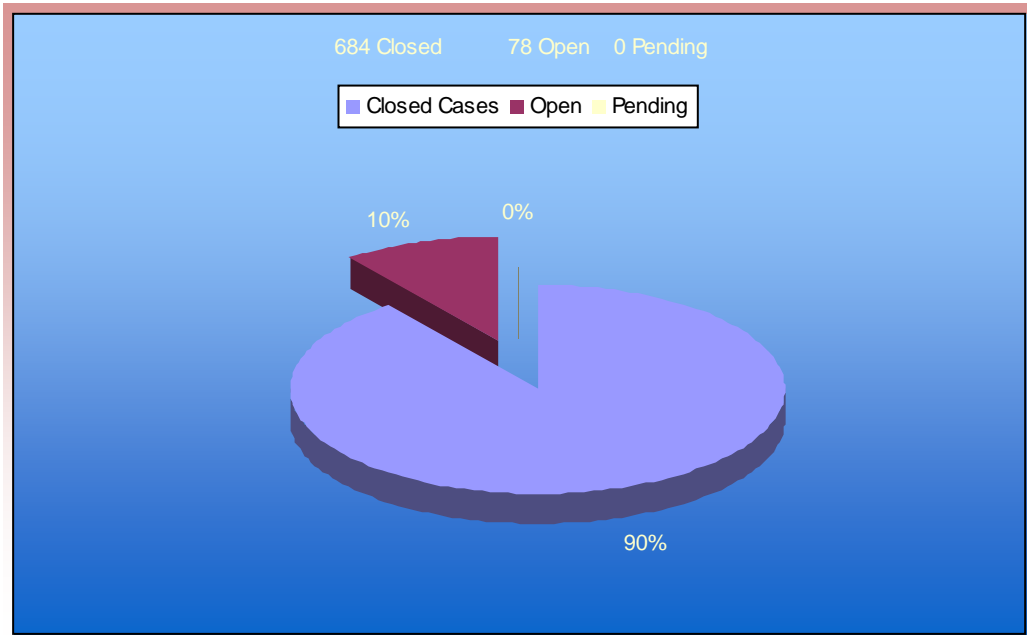
DETECTIVE BUREAU



The Detective Bureau is the Criminal Investigation Unit for the Department. The detectives assigned to this unit are responsible for investigating all crimes committed against persons or property in the community. They are available to respond to a crime scene 24 hours a day. All detectives receive specialized training to develop and enhance their investigative skills including attending legal update training and meetings with detective bureaus from neighboring jurisdictions. The Detective Bureau is also responsible for monitoring businesses that possess a Michigan liquor license to ensure compliance with Michigan liquor laws.

The Grosse Pointe Woods Detective Bureau consists of Detective Kevin Bonk, Detective Anthony Chalut, and Traffic Safety Officer/Detective Daniel Koerber. Together, these detectives are responsible for investigating crimes, collecting and preserving evidence, identifying perpetrators, interviewing witnesses, interrogating suspects, and preparing cases for successful prosecution. The Detective Bureau operates under the supervision of Lt. Keith Waszak.

DETECTIVE BUREAU (continued)



90% of the 762 Criminal Cases assigned to the Detective Bureau in 2014 are closed.

Detective Daniel Koerber, the Department's Youth Officer, is responsible for any crimes and or violations involving persons under the age of 17. He has an office located at Grosse Pointe North High School and has become a direct liaison with school administrators, teachers, and students. Detective Koerber is an educator and mentor for all students in the Grosse Pointe School System. Detective Koerber is also responsible for traffic safety, overseeing crossing guards, conducting traffic and speed studies, and investigating traffic-related incidents as well as the Community Crime Prevention Program



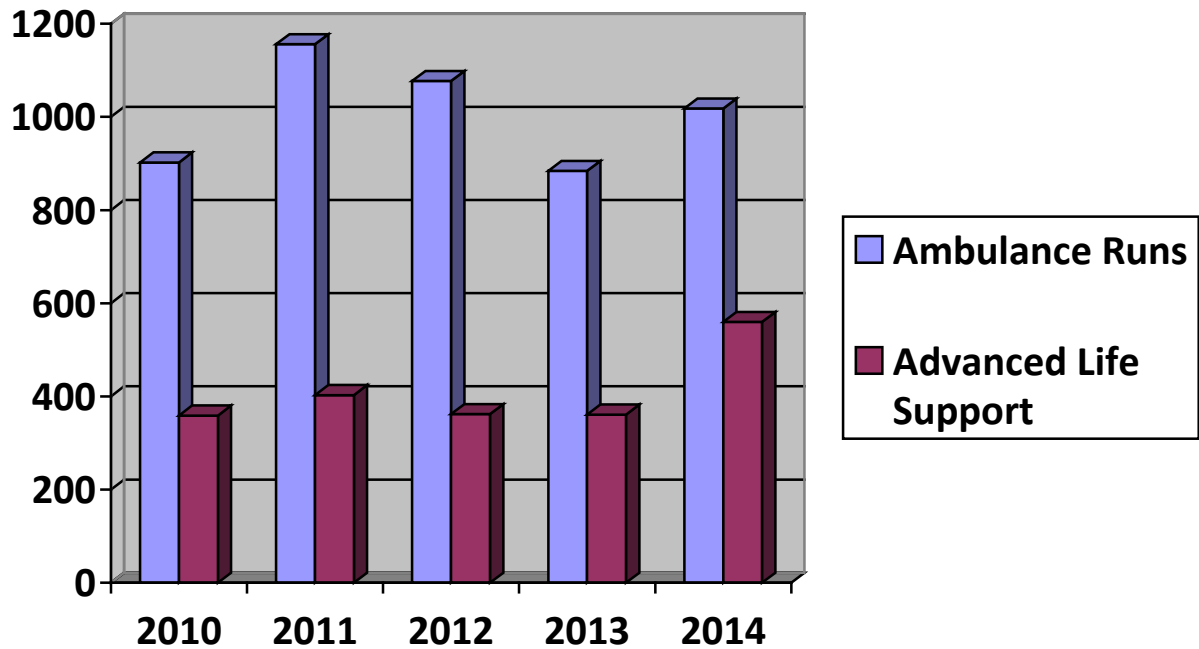

EMERGENCY MEDICAL SERVICES

In the spring of 2014, the City contracted with Medstar Ambulance to provide dedicated emergency ambulance service. The Medstar personnel working for Grosse Pointe Woods are assigned to city quarters and respond from here. In addition, a public safety officer also responds to every ambulance run. All of our patrol vehicles are equipped with Automatic External Defibrillators (AED's). The switch to a privatized ambulance service is designed to save the city money without sacrificing the quality of service or patient care for our residents.

With enhanced technology and equipment, the paramedics from Medstar can begin advanced lifesaving procedures and transmit reports to area hospitals before the patient arrives.

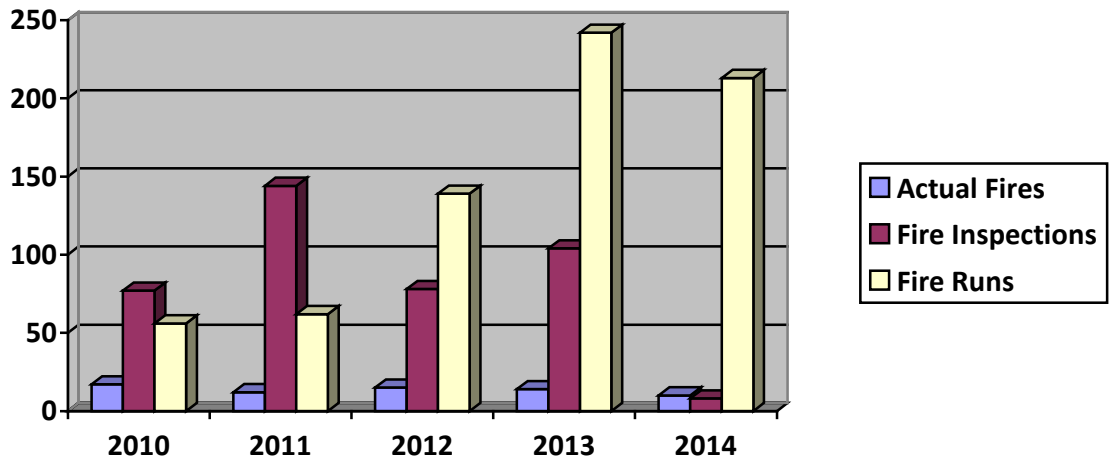
The 1018 ambulance runs in 2014 represents a 15% increase from the 884 runs in 2013 and the 560 runs involving advanced life support represents a 55% increase from the 361 advanced life support runs in 2013.

FIRE OPERATIONS

The Department prides itself on its quick response to all emergencies. In addition to the 10 dwelling fires in Grosse Pointe Woods, our firemen also responded to 3 other fires at or in single family dwellings, 1 commercial building fire, 1 vehicle fire, 4 dumpster/outside fires, and 1 trench rescue. We also provided mutual aid to Harper Woods, Grosse Pointe Farms, and Grosse Pointe Shores. There were 14 fires in these communities requiring mutual aid in 2014. The dramatic drop of fire inspections in 2014 is due primarily to the temporary re-assignment of Fire Inspector Joseph Provost to road patrol for the majority of the year due to staffing changes.

DISPATCH

911

Three numbers which can mean the difference between life and death. Each and every day, dispatchers are faced with a multitude of calls for police and medical emergencies. It is imperative that the dispatcher be alert, quick, and accurate in responding to these calls regardless of the time of day or night. The City of Grosse Pointe Woods Public Safety Department is fortunate to have a seasoned team of two full-time and four part-time dispatchers on staff who are capable of handling any emergency. An event such as a bad storm can also cause a flood of incoming calls regarding downed power lines, flooding, accidents, etc...

Our dispatchers also provide a much appreciated service to senior residents on the daily call list by calling to check on their welfare. These calls provide a sense of security to the seniors.

An important piece of advice that our dispatchers would like to relay to callers is to identify their location. Most people incorrectly believe that when they call 911 from a cell phone that the dispatcher will know exactly where they are not realizing that the location which is tracked may be that of the nearest cell tower rather than the location the call is being made from. The location is essential in the event that the contact is lost with the caller so that an officer can be sent out.

DEPARTMENT TRAINING

Each year, officers train with the specialized rescue tools and fire equipment used by the Department. Members of the Department attended 384 hours of Police and Fire training courses at local colleges and other training facilities in 2014 and also participated in 780 hours of in-house training. The Department received a total of 1,164 hours of training in 2014.

SPECIAL RESPONSE TEAM (SRT)

The Special Response Team (SRT) is a specially trained 13-member cross-jurisdictional law enforcement team which responds to potentially dangerous situations. The SRT executes search and arrest warrants, intervenes in hostage situations, works on counter-terrorism missions, provides perimeter security for high-profile events, and provides assistance in other high-risk situations.

In 2014, the SRT was activated on 7 separate occasions. The SRT worked together with the ACTION task force, Federal authorities, and Detroit, Hamtramck, and Highland Park officers in one of these activations involving an auto theft ring which resulted in an arrest and the recovery of thousands of dollars and numerous stolen vehicles. Other SRT searches resulted in a felony arrest, the break up of a large theft ring, and the recovery of various drugs and guns.

CROSSING GUARDS

AUXILIARY UNIT

The volunteer Auxiliary Unit is a vital resource for the Department. The Auxiliary Unit underwent 167 hours of training and devoted 656 hours of service to the City of Grosse Pointe Woods in 2014. They are an indispensable part of our community.

Officer Robert Raymond retired after 28 years of hard work and dedication.

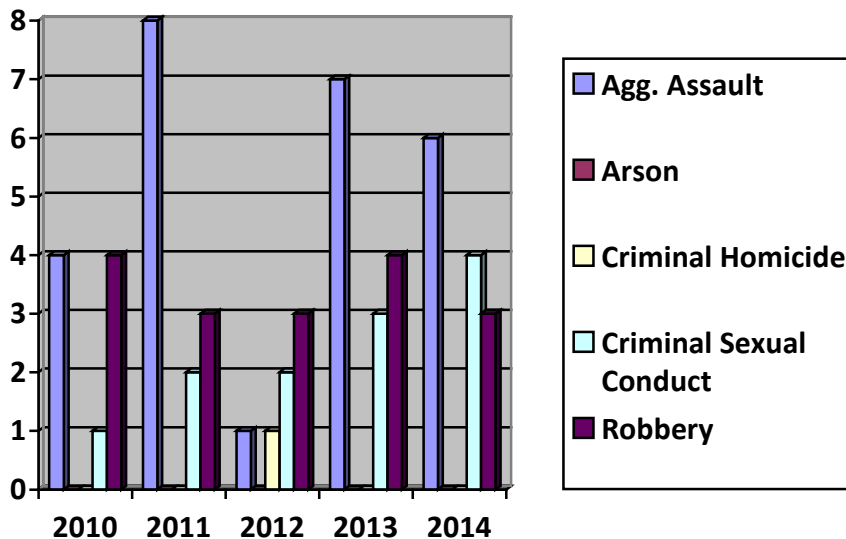
INDEX CRIMES BREAKDOWN

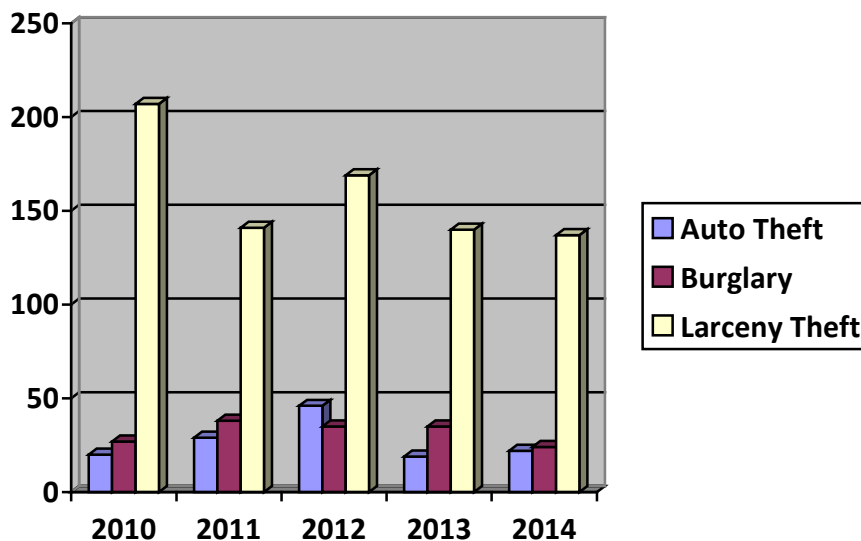

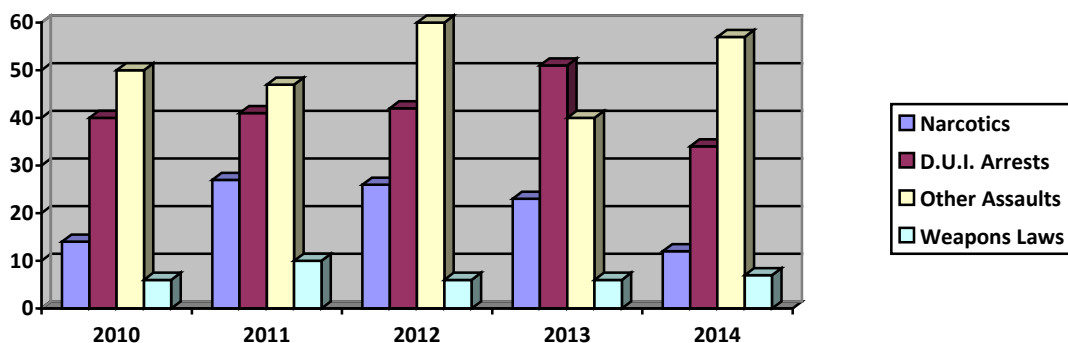
NON-INDEX CRIMES BREAKDOWN

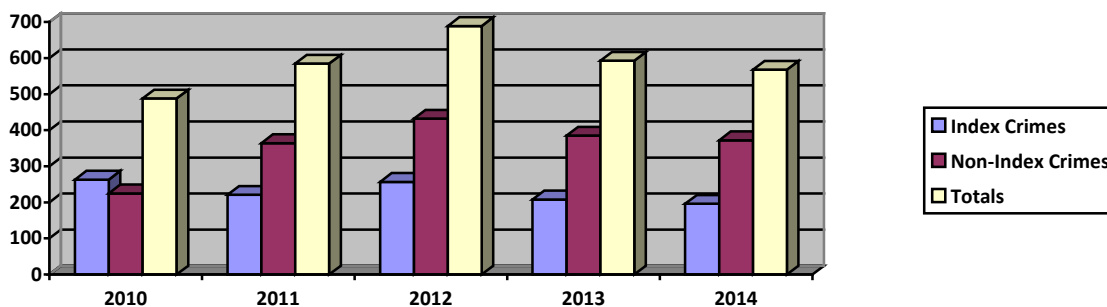

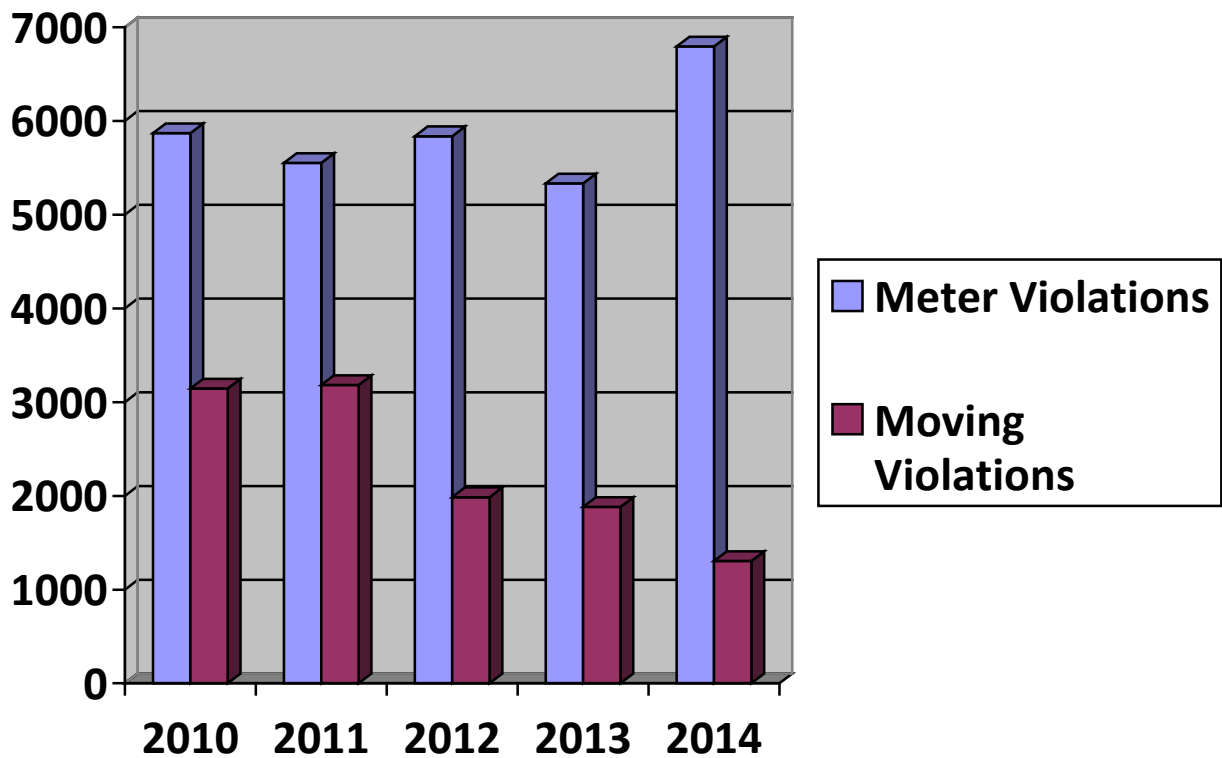

MOVING AND METER VIOLATIONS

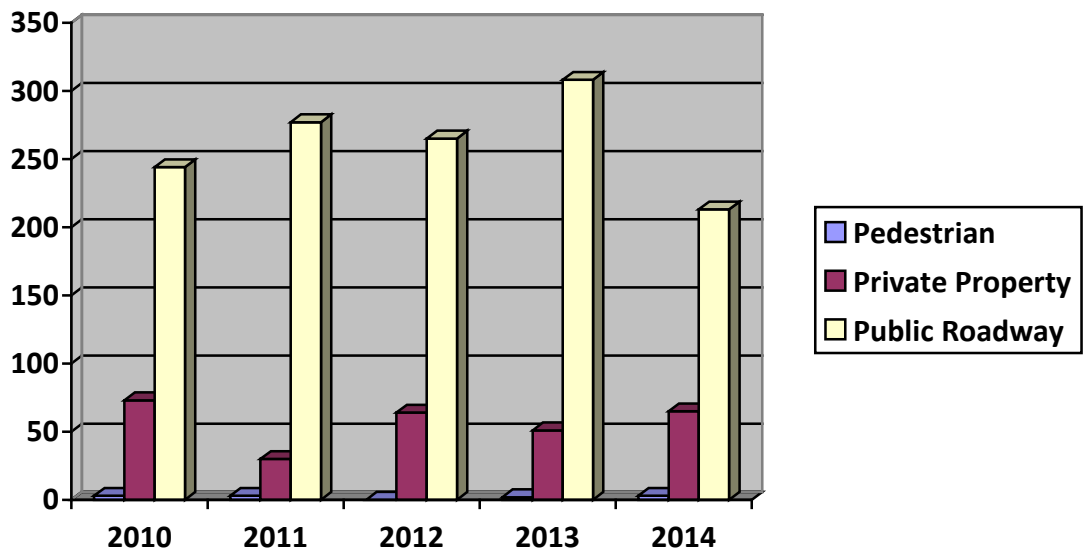

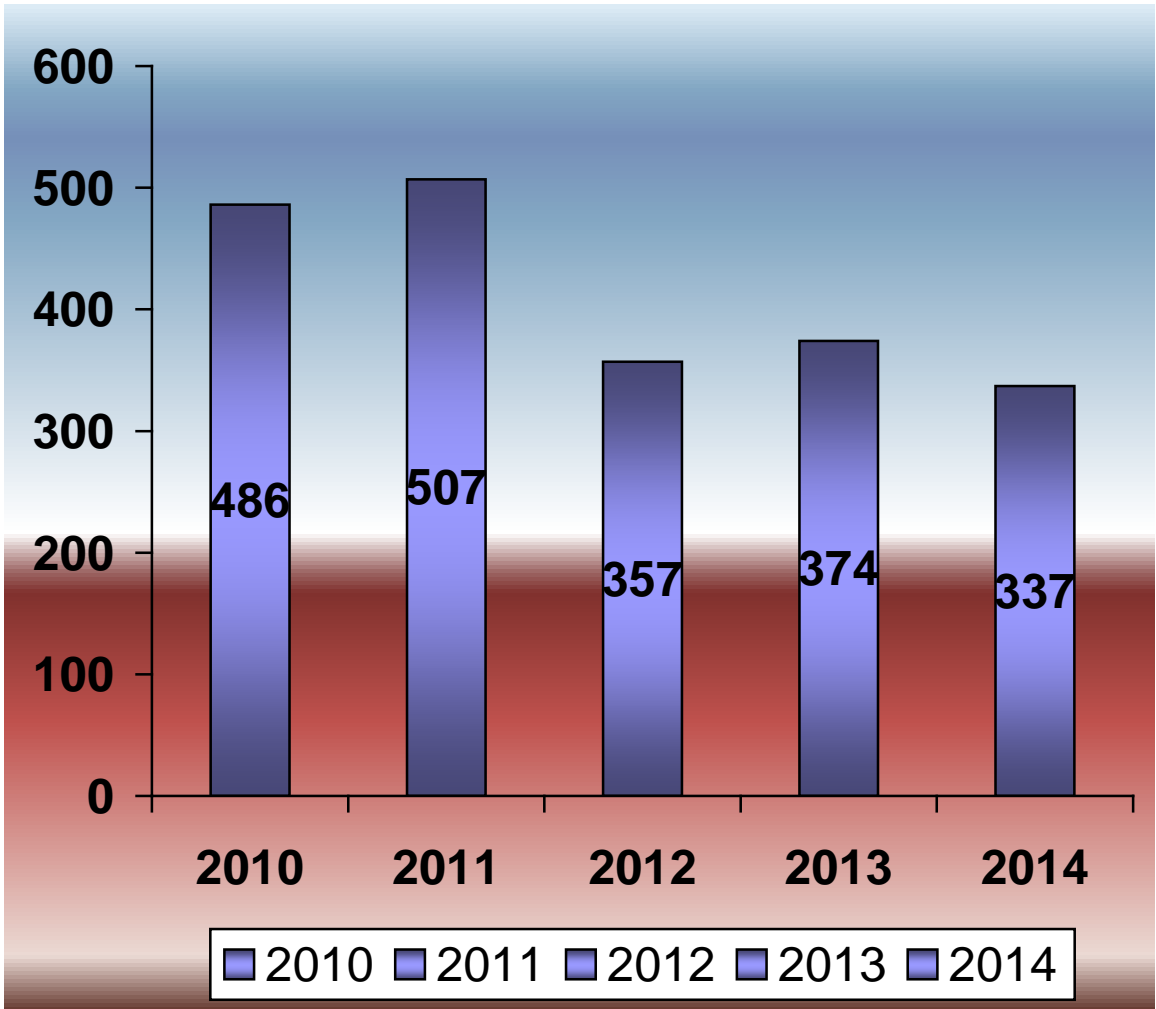
