Notice Pursuant to Executive Order No. 2020-77

MILK RIVER INTERCOUNTY DRAIN

Notice is hereby given that pursuant to Executive Order No. 2020-77 ("EO 2020-77") of the Governor of the State of Michigan the Milk River Intercounty Drain Drainage Board hereby determines and designates all persons working on site of the Priority 1B and Select Improvements Project ("Project"), persons working on property protection measures to prevent flooding within the Milk River Intercounty Drain Drainage District, as well as all persons operating the Milk River Facilities as "critical infrastructure workers" as described in Paragraphs 5(a), 8(e) of EO 2020-77, as well as the March 19, 2020 Memorandum on Identification of Essential Critical Infrastructure Workers During Covid-19 Response of the U.S. Cybersecurity and Infrastructure Security Agency (Department of Homeland Security).

During the pendency of EO 2020-77, the following measures shall be taken as much as practical on any site of the Project:

1. Developing a COVID-19 preparedness and response plan, consistent with recommendations in Guidance on Preparing Workplaces for COVID-19, developed by the Occupational Health and Safety Administration. Such plan must be available at company headquarters or the worksite.
2. Restricting the number of workers present on premises to no more than is strictly necessary to perform the in-person work permitted under EO 2020-77.
3. Promoting remote work to the fullest extent possible.
4. Keeping workers and others who are on premises at least six feet from one another to the maximum extent possible.
5. Increasing standards of facility cleaning and disinfection to limit worker and patron exposure to COVID-19, as well as adopting protocols to clean and disinfect in the event of a positive COVID-19 case in the workplace.
6. Adopting policies to prevent workers from entering the premises if they display respiratory symptoms or have had contact with a person with a confirmed diagnosis of COVID-19.
7. Any other social distancing practices and mitigation measures recommended by the CDC.
8. Prohibit gatherings of any size in which people cannot maintain six feet of distance from one another.
9. Limit in-person interaction with clients and patrons to the maximum extent possible, and bar any such interaction in which people cannot maintain six feet of distance from one another.
10. Provide personal protective equipment such as gloves, goggles, face shields, and face masks as appropriate for the activity being performed.

11. Adopt protocols to limit the sharing of tools and equipment to the maximum extent possible and to ensure frequent and thorough cleaning and disinfection of tools, equipment, and frequently touched surfaces.
12. Designate a site-specific supervisor to monitor and oversee the implementation of COVID-19 control strategies developed under subsection (a) of this section. The supervisor must remain on-site at all times during activities. An on-site worker may be designated to perform the supervisory role.
13. Conduct a daily entry screening protocol for workers, contractors, suppliers, and any other individuals entering a worksite, including a questionnaire covering symptoms and suspected or confirmed exposure to people with possible COVID-19, together with, if possible, a temperature screening.
14. Create dedicated entry point(s) at every worksite, if possible, for daily screening as provided in subprovision (3) of this subsection, or in the alternative issue stickers or other indicators to workers to show that they received a screening before entering the worksite that day.
15. Provide instructions for the distribution of personal protective equipment and designate on-site locations for soiled masks.
16. Encourage or require the use of work gloves, as appropriate, to prevent skin contact with contaminated surfaces.
17. Identify choke points and high-risk areas where workers must stand near one another (such as hallways, hoists and elevators, break areas, water stations, and buses) and control their access and use (including through physical barriers) so that social distancing is maintained.
18. Ensure there are sufficient hand-washing or hand-sanitizing stations at the worksite to enable easy access by workers.
19. Notify contractors (if a subcontractor) or owners (if a contractor) of any confirmed COVID-19 cases among workers at the worksite.
20. Restrict unnecessary movement between project sites.
21. Create protocols for minimizing personal contact upon delivery of materials to the worksite.
