RE: Roslyn Rd Water Main & Resurfacing

Dear Resident:

The City of Grosse Pointe Woods has awarded a contract to Pamar Enterprises, Inc. for the replacement of the water main and resurfacing of Roslyn Road from Mack Avenue to Marter Road. The exact start date is unknown until the permit is approved by the Department of Environment, Great Lakes, and Energy. However, weather permitting, tree removals are tentatively scheduled to begin the week starting Monday, August 28.

Prior to work beginning, you will likely see green dots along the street. These are used to call out existing cracks in nearby sidewalks and driveways prior to the contractor completing a video survey of the construction area. Also, prior to work beginning, we ask that you flag or identify any sprinkler heads or lines that may be located between the sidewalk and roadway. While the contractor will try to work around the sprinkler systems, they can often become damaged during construction and will be repaired. You may be approached by a representative of the contractor prior to work beginning to document the sprinkler systems, and the contractor will work with you after construction to replace any components that may have been damaged during construction.

Tree Removals

In order to excavate to depths and locations necessary for reconnecting water services, installing valves, or installing hydrants, or to facilitate construction of new curbs, there may be severe impacts to existing trees or their root systems. Consequently, a number of trees will require removal to facilitate construction of the new curb, water main, services, valves, and hydrants. Trees designated for removal will be marked with a painted "X". New trees will be replaced as part of the project.

During Construction residents will have limited access to the street daily between 7:00 a.m. and 7:00 p.m. due to construction activity. Additionally, there will be various extended periods of time where some residents will not have access to their driveways. Prior to any loss of driveway access, advance notice will be provided by hand delivered flyer. At a minimum, one-way traffic, will be maintained at all times, with few temporary exceptions for full closures. No parking will be allowed on the street. Parking will be allowed overnight on nearby city streets except in posted fire route lanes. The Public Safety Department is aware of the construction and parking permits will not be required.

General Consideration: Please place garbage curbside by 7:00 a.m. as usual. **Please place BAGS ONLY at the curb in order to facilitate garbage removal during construction.** Recycling and brush will not be picked up curbside during construction. Residents may bring their **recycling only** to the Department of Public Works between 8:00 am and 3:00 p.m. Monday through Friday.

There will be an informational meeting for residents on Wednesday, August 23, 2023 at 6:00 p.m. in the Community Center at City Hall. I will conduct the meeting and there will be representatives present from the city's engineering firm Anderson, Eckstein & Westrick (AEW) and Pamar Enterprises, Inc. to answer any questions you may have.

Construction observation will be performed by AEW. Questions regarding construction operations should be directed to their attention at (586) 726-1234. Please direct any other questions to the Department of Public Works (313) 343-2460.

We know that construction can be inconvenient and disruptive. Your patience and cooperation are greatly appreciated as we work to improve our community's infrastructure.
