Motion by Granger, seconded by Howle, regarding Zoning Board of Appeal: Mariano Pacini, 19846 Ida Lane East, who is requesting a variance to install a 16' x 16' shed encroaching onto utility and Milk River easements, that the Zoning Board of Appeal concur with the recommendations of the Building Official, and Directors of Public Works and Public Safety, and grant the 16' variance request based on the practical difficulty that exists, contingent upon the following:

- 1. Granting of this variance does not relinquish the City's rights to the easement;
- 2. Use of the easement is at the sole risk of the property owner and may require removal of the structure at the property owner's expense at the request of the City if work is required in the easement;
- 3. The property owner provide an acknowledgement to the City indicating that the property owner or successors are responsible to remove the encroachment at their expense if work needs to be done in the easement;
- 4. Construction commence within 90 days and completed in 180 days.
