BARROTT AND JOHN LYDICK, 1984 FLEETWOOD DRIVE,** WHO ARE APPEALING THE DENIAL OF THE BUILDING INSPECTOR TO ISSUE A BUILDING PERMIT TO **INSTALL SOLAR PANELS** AT THEIR HOME ON 1984 FLEETWOOD DRIVE, GROSSE POINTE WOODS. THE PERMIT WAS DENIED DUE TO NONCOMPLIANCE WITH SECTION 50-539(2) SOLAR ENERGY SYSTEMS OF THE 2007 CITY CODE. A DIMENSIONAL VARIANCE IS THEREFORE REQUIRED.

The Chair asked if anyone from the audience wished to speak in opposition to the proposed request. The Building Official spoke in opposition, stating that the City's Fire Inspector is also opposed as indicated in his memo dated May 20, 2014.

The Planning Commission and Building Department were asked to review the solar panel ordinance and 2012 Fire Code, and to provide a recommendation to the City Council.

Motion by Granger, seconded by Shetler, regarding Zoning Board of Appeal: Wendy R. Barrott and John Lydick, 1984 Fleetwood Drive, that the request for a variance to install solar panels be denied of Sec 50-539(5) regarding installation of solar energy panels as there is a question of public safety and welfare.

Motion by Granger, seconded by Shelter, to amend previous motion by deleting, "as there . . . and welfare.", and inserting, "1. . . . property." as follows:

- 1. Granting the variance would impact the spirit and intent of the ordinance, and it would negatively impact the health safety and welfare of the community;
- 2. The problem is self created;
- 3. The plight of the Petitioner is not due to the City or unique circumstances;
- 4. It would be more consistent with justice to deny than to grant the variance;
- 5. Denial of the variance would not prevent the Petitioner from using the property."
